Barbara,

I'm waiting for the September reports from TSC to come in so I don't have the exact numbers at this time. If you can accept an approximate, it is:

Centers received 567,580 TECS hits in the BCU for resolutions  
They referred 9350 to the CFDO  
They identified 96785 as DNR  
They created 466768 resolutions

We get approximately 6000 CARRP cases in and we have been closing out the same amount (slightly less), for the last 2 years we have been completing all of these by May, so we are on about a 5 month processing time. This is Non KSTs, the **KSTs cannot be approved and that is why we have some cases over 3 years pending.** To date, without TSC Septembers numbers we:

Received 6023 CARRP cases  
Closed 3089 as Non NS  
Transferred 439 to Field Offices  
Closed 2402

We received 4270 cases for NTAs  
We issued 1356 NTAs  
We referred 2622 to ICE

If you need me to update the numbers once TSC submits their September numbers, please let me know.
