Attached please find CRB/NSD's proposed approach to the **LE** ase. We also reached out to Fraud Division to collect their input regarding questions/concerns and have incorporated their suggestions as well. Although this case is a non-KST and potentially a non-NS, because of the nexus to her husband, we feel she may be an NS concern...not so much because she is a national security threat who may attack USCs or interests, but because she is the spouse of a Known Terrorist and as far as we can determine has never disavowed his actions or expressed remorse (at least not in the files we reviewed). As we discussed, if she is considered a non-KST, this case could still be elevated to the SLRB if the field desired to do so as the SLRB considers non-KSTs that have the potential to become high vis cases. Whatever approach is taken in resolving this case, our team is ready to assist, if necessary. We will begin the process of returning the A-files on Monday.
