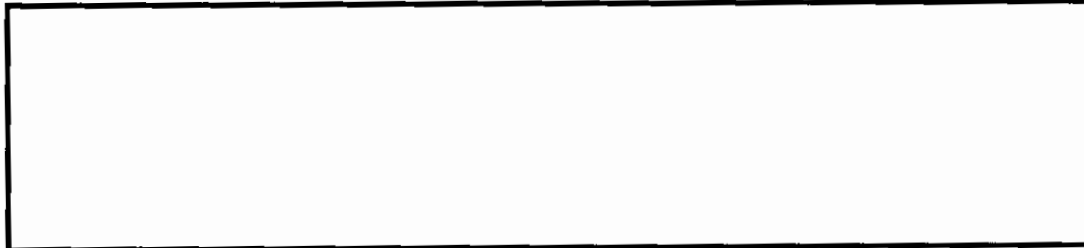

ORDER

On November 15, 2018, the Government filed a notice of appeal, petition for review, and a motion under seal in the above-captioned matter. The Government's motion under seal sought a stay of portions of the Foreign Intelligence Surveillance Court (FISC) orders of October 18, 2018 concerning the above-referenced certifications (hereinafter the "Correction Orders") during the pendency of this Court's review of those orders. On November 16, 2018, this Court issued an order which granted relief as requested in the Government's motion, subject to the Government's adherence to the use limitations set forth in 50 U.S.C. § 1881a(j)(3)(D).

Pursuant to 50 U.S.C. § 1803(i)(2)(A) and Rule 15(a) of this Court's Rules of Procedure, the Court appoints amici curiae, who have been designated under 50 U.S.C. § 1803(i)(1), "to assist . . . in the consideration of any application for an order or review that, in the opinion of the court, presents a novel or significant interpretation of the law, unless the court issues a finding that such appointment is not appropriate." These individuals shall assist the Court in considering the issues specified in the Government's pending appeal. The Court intends for them to work together and submit a joint brief on those issues pursuant to the schedule set forth below.



Accordingly, it is **HEREBY ORDERED** as follows:

- (1) Jonathan G. Cedarbaum and Amy Jeffress are appointed as amici curiae in this matter pursuant to 50 U.S.C. § 1803(i)(2)(A) and Rule 15(a) of this Court's Rules of Procedure. The amici are directed to address the issues specified in the Government's opening brief.
- (2) At the request of amicus Amy Jeffress and pursuant to 50 U.S.C. § 1803(i)(5), the Court appoints John Cella, Esq. to assist Ms. Jeffress and amicus Jonathan G. Cedarbaum in their service to the Court in this matter. Mr. Cella shall have access to the same materials to which Mr. Cedarbaum and Ms. Jeffress have access in their capacity as amici in this matter.
- (3) The following briefing schedule shall govern these proceedings:
 - a. The government shall file an opening brief by December 13, 2018;
 - b. Amici shall file their responsive brief by January 14, 2019;
 - c. The government shall file any reply by January 28, 2019; and
 - d. The Court, after consulting the government and amici, may set oral argument.
- (4) All briefs shall conform to the requirements of Rules 14 and 16 of this Court's Rules of Procedure.

The government's submissions shall include copies of materials cited therein unless those materials are publicly available.
