ORDER APPOINTING ADDITIONAL AMICUS CURIAE

Amicus Amy Jeffress has requested the appointment of Tianyi Xin, Esq., to assist Ms.

Jeffress in this matter. The Security and Emergency Planning Staff (SEPS) of the United States

Department of Justice has advised the Court that Tianyi Xin has been determined to be eligible for access to Top Secret/Sensitive Compartmented Information.

Accordingly, in order to aid in effective amicus participation, it is HEREBY ORDERED as follows:

- (1) Pursuant to section 103(i)(2)(B) of the Foreign Intelligence Surveillance Act of 1978, as amended (FISA), codified at 50 U.S.C. § 1803(i)(2)(B), Tianyi Xin is appointed to serve as amicus curiae in this matter. The Court intends for Tianyi Xin to have access to the same materials as Ms. Jeffress in her capacity as amicus in this matter. If, however, the government believes that such access is not "consistent with the national security of the United States," id., § 103(i)(6) (C), it shall provide written notice and explanation to the Court by December 30, 2020.
- (2) Tianyi Xin's work as an amicus, including the proper safeguarding of classified information, shall be subject to paragraphs (2) through (6) (on pages 3 through 5) of this Court's Order Appointing Amici Curiae, entered on December 14, 2020, in the above-captioned matter.


