## Monthly OPLA Update January 21, 2020

### **OPLA Headlines**

- OPLA welcomes its new Principal Legal Advisor, Tony Pham, who most recently served as Superintendent of the Virginia Peninsula Regional Jail, and has also served as General Counsel to the Richmond City Sheriff's Office, an Assistant City Attorney in Richmond, and a Senior Assistant Commonwealth's Attorney in Richmond, among other duties and accomplishments.
- Potential Inability to Appear for All Removal Hearings: Despite OPLA's aggressive hiring efforts, OPLA continues to face severe resource constraints that may prevent it from appearing in all removal hearings as soon as Spring 2020 in New York City, San Francisco, and Los Angeles. This is a result of rapid Executive Office for Immigration Review (EOIR) hiring and expansion that OPLA cannot match because Congress has not provided corresponding appropriations. OPLA received 169 notional enhancement positions in its Fiscal Year (FY) 2020 appropriations; however, the reality is that the amount provided is unlikely to allow for much beyond maintaining FY 2019 staffing levels. As a result, it is likely that OPLA will not be able to appear for all immigration court hearings in some locations. OPLA has developed a prioritization plan of its litigation efforts before EOIR, particularly in those locations where OPLA's staffing situation prevents its appearance for every hearing and has prepared a briefing memorandum for DHS leadership seeking concurrence with this plan. In the interim, OPLA continues to draw down its few remaining Special Assistant United States Attorneys and is looking at whether to discontinue client-embedded attorney positions to be able to cover court.

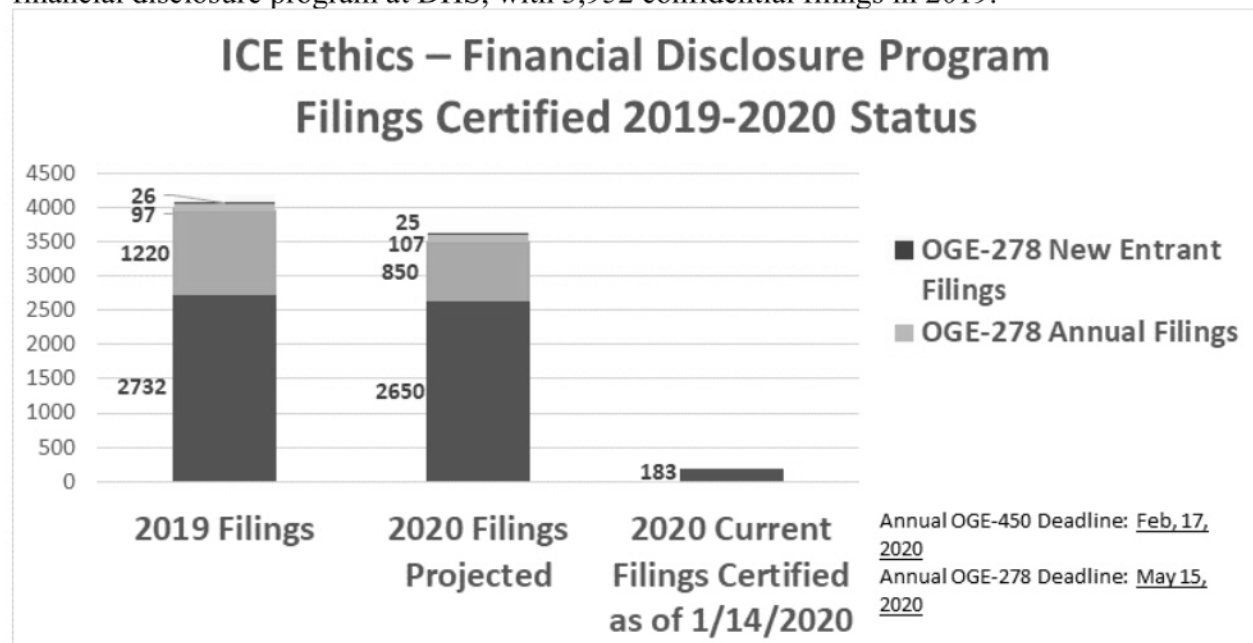

- MPP returns expanded to Nogales and Yuma, AZ in November 2019. MPP cases generated out of Arizona are being docketed in EOIR El Paso. During the week of November 25, 2019, OPLA El Paso received 104 of these cases and, as of January 13, 2020, has received 545 Arizona-generated cases.
- Individual MPP merits hearings began on January 2, 2020, using immigration judges (IJ) from Ft. Worth and distant OPLA field locations. Currently, 4 IJs are hearing cases in Brownsville and 2 in Laredo. A fifth IJ will begin hearing Brownsville cases on January 22. OPLA field locations covering these hearings are Buffalo; St. Paul (Omaha); Chicago (Louisville, KY); and San Antonio (Port Isabel). There have been a few minor glitches with virtual connections and equipment that have since been resolved. These types of hearings will expand to OPLA Miami and OPLA Los Angeles by the end of January.

### **Financial Disclosure**

The Ethics Office launched the 2020 annual financial disclosure season for public and confidential filers on January 2, 2020, providing notice to approximately 2,750 annual filers. Managing the financial disclosure program at ICE is a year-long endeavor, requiring significant preparation, interaction with over 4,000 employees and supervisors, and certification by an Ethics Attorney within regulatory deadlines. The program is audited by KPMG every year and monitored by the Office of Government Ethics. The financial disclosure forms examine different categories of interests-assets/income, liabilities, non-Federal positions, agreements and arrangements, gifts/travel reimbursement, and for some filers, liabilities. To date, ICE has the largest confidential financial disclosure program at DHS, with 3,952 confidential filings in 2019.

Current geolocation offerings in the commercial market have not met the needs of all HSI analysts and agents; government owned and operated solutions are currently under consideration to provide robust coverage in areas of strategic interest.**

We got a weekend task from OGC based on a WSJ article that came out on Venntel (the geolocation software that uses subscriber opt-ins on various apps). We have a handle on the bulk of the response but need an assist on the Stingray FOIA litigation (see highlighted language below).
