Pursuant to this Court's Order of November 15, 2024, ECF No. 74, the parties jointly submit this status report. On January 20, 2024, President Trump withdrew Executive Order No. 14019, *Promoting Access to Voting*, 86 Fed. Reg. 13,623 (Mar. 7, 2021), the subject of this litigation. *See* Exec. Order No. 14,148, *Initial Recissions of Harmful Executive Order and Actions*, 90 Fed. Reg. 8237, 8238 (Jan. 20, 2025) (revoking Executive Order No. 14019). Accordingly, the parties believe that the case is moot. The stay of all proceedings imposed by the Order should be lifted to allow Plaintiffs to voluntarily dismiss their action.
