DECLARATION OF ANTHONY ANSCOMBE IN SUPPORT OF PLAINTIFFS' MOTION FOR CLASS CERTIFICATION

My name is Anthony Anscombe. I am over the age of 18 and fully competent to make this declaration. Under penalty of perjury, pursuant to 28 U.S.C. § 1746, I declare:

- 1. I am a Partner in the law firm of Steptoe LLP (F/K/A Steptoe & Johnson LLP), and am one of the Counsel of Record for Plaintiffs in this matter. My office affiliations are Chicago (where I live), and San Francisco, where I have practiced over the full course of my career.
- I graduated from the University of Virginia School of Law in 1988. I became a member of the California Bar in December, 1988, and a member of the State Bar of Illinois in 1999. I am admitted to the bars of many different U.S. District Courts, numerous U.S. Circuit Courts, and to the U.S. Supreme Court.
- In February, 2025, I agreed to lead a team of Steptoe attorneys in assisting the American Civil Liberties Union Foundation ("ACLU") and American Civil Liberties Union Foundation of Florida ("ACLU-FL") in their prosecution of this case.
- 4. I submit this declaration in support of Plaintiffs' Motion for Class Certification, and to seek the appointment of Steptoe LLP to serve as cocounsel for the proposed class, along with counsel from the ACLU and ACLU-FL. (Counsel at ACLU and ACLU-FL will submit a separate declaration in support of their request to serve as class counsel.)

- 5. With respect to my own qualifications, I have been in private practice continuously since September, 1988. From 1988 to 2017, I practiced at the now defunct firm known as Sedgwick LLP (previously Sedgwick, Detert, Moran & Arnold), an Am Law 200 firm headquartered in San Francisco with offices around the United States, Bermuda, and London. I joined Steptoe on January 1, 2018. Steptoe is an Am Law 100 firm, headquartered in Washington D.C., with offices in six U.S. cities, London, Brussels, Beijing, and Hong Kong. In 2024, I became chair of Steptoe's Consumer Law and Litigation Practice. I attach my firm bio as Exhibit A.
- 6. Over my career, the defense of class action litigation has been at the core of my practice. I long ago lost track of how many class actions I have defended, but I estimate that the number likely exceed 200 separate matters. I have written and lectured extensively about class litigation, as well as the substantive legal theories that drive class litigation. Based on my career experience and professional interest, I have become deeply knowledgeable about class litigation.
