

Vote NO On H.R. 32, "Defund Our Communities" Act

We expect a floor vote on H.R. 32, which should be called the *Defund Our Communities Act*, as soon as February 24. This bill, if enacted, would cut federal funds to hundreds of jurisdictions across the country, freezing funds for critical services in our communities

Social workers, police officers, teachers, bus drivers: They all stand to lose funding —and possibly their jobs—if H.R. 32 becomes law. That's why leading unions including SEIU, NEA and AFT oppose H.R. 32.

Bill Summary

H.R. 32 would allow the Executive Branch to strip a state or local government of federal funds it "intends to use for the benefit" of undocumented immigrants. While couched in terms of immigration, we fear the actual result of this bill would be a funding cut off across the board, putting critical services to all our community members at risk. As you well know, state and local agencies do not generally segregate their funding allocations for citizens versus noncitizens, let alone noncitizens without legal status versus all others.

Tens of thousands of state and local employees—social workers, police officers, teachers, bus drivers, and more—stand to lose funding they rely on to do their jobs serving our communities. Countless small businesses with contracts that serve those federal funding recipients could be impacted. The bill specifically names federal funding for "food, shelter, healthcare services, legal services, and transportation," but leaves the door open to "any" funding being cut. In its first few weeks, this administration has already proven that it will stretch any legal authority far beyond the intended purpose or, as their track record in court so far would suggest, beyond the limits of that authority.

The bill would harm hundreds of localities across the country. ICE has a list of hundreds of "noncooperative" and "limited cooperation" state and local jurisdictions—across 32 states and Washington, D.C.—all of which stand to lose funding based on the bill, ¹ and including many which do not even consider themselves "sanctuary" but have local jails that do not have enough space to hold people for ICE.

The bill requires an annual report on which jurisdictions are in "compliance"--which could be expanded and weaponized to include a growing list of cities, counties, and states that the administration wishes to punish or make an example of.

Chaos & Federal Funds

• Trump just attempted to freeze federal funds with no consideration for the chaos and confusion it would cause. Now he wants Congress to pass a bill, which should be called the *Defund Our Communities Act*, that will allow him to strip our communities of badly needed federal funding.

• If HR 32 is enacted, it could give Trump the power to cut off federal funding to communities in hundreds of communities across 32 states and D.C. -- putting tens of millions of American families at risk of losing vital services, from Meals on Wheels to the local bus line.

Holding the Door Open For ICE At Our Churches, Schools and Hospitals

- Trump is threatening to cut federal funding if state and local officials refuse to hold the door
 open for ICE as it raids our places of business and threatens to enter our schools and churches.
 He's attempted this in executive order, and now he wants Congress to pass a bill along the same
 lines that could cut federal funding to hundreds of communities.
- Local communities should be able to focus their limited resources on local community
 needs. Defund Our Communities Act puts Trump's deportation agenda above all other needscritical law enforcement, disaster assistance, education support, infrastructure support—and
 would force our communities to go along with it.
- Congress should not effectively force cities and states to devote local resources to immigration
 enforcement—that is a federal responsibility being outsourced to state and local governments
 with no recompense.
- If Congress gives Trump the power to hold our communities hostage on immigration, it will only
 embolden his attacks on all our civil rights and elected officials who dissent from his agenda in
 any way.

Hard Question: Does sanctuary protect criminals at the costs of our communities?

- No, these laws do not prevent jurisdictions from enforcing their criminal laws against immigrants or anyone else. The federal government is notified of every single individual booked into a local jail; and nothing is preventing ICE from picking up individuals when they are released from local custody, this is a matter of ICE prioritization and ICE decision-making. But forcing communities to honor an ICE detainer (a 48-hour hold) means communities are prioritizing jail space for ICE rather than local public safety threats.
- Studies show that sanctuary policies cut in half the deportation of people with no criminal convictions, while having no effect on deportation of people with convictions for violent crimes.
 That's likely because most sanctuary policies have exceptions for people convicted of serious crimes, allowing local law enforcement to hold them and coordinate their transfer to ICE.

Hard Question: Does sanctuary prevent ICE from doing its job?

- No. Sanctuary is about states and cities choosing to focus their resources on local needs rather
 than the federal government's immigration agenda. The reality is, ICE has federal authority to
 operate anywhere in our nation, and no city or county is preventing them from doing their jobs.
- For decades, all local jurisdictions have shared the fingerprints of people booked in custody with the FBI to see if they have outstanding warrants against them. The FBI shares that information with DHS. That means DHS is already notified of every single individual taken into state or local custody, regardless of "sanctuary" status.



- Most of these "sanctuary" policies have exceptions for people convicted of serious crimes, allowing local law enforcement to hold them and coordinate their transfer to ICE custody.
- Many jurisdictions inform ICE when someone is being released or will hold them depending on their criminal convictions. These should remain local-level decisions—not the full all or nothing demand of the Trump administration.

Annex: Congressional Districts That Stand to Lose All Federal Funding Under H.R. 32

Hundreds of communities across **32 states** stand to lose federal funding under this bill, which defines "sanctuary" jurisdictions to include all those that decline to extend the detention of someone in jail in response to a detainer request from ICE, no matter the reason.

Entire states stand to lose **state-level eligibility** for federal funding due to state laws and judicial decisions that limit local authority to honor ICE detainers and other forms of collaboration with federal immigration enforcement, including: California, Colorado, Connecticut, Illinois, Maryland, Massachusetts, Minnesota, New Jersey, Oregon, Rhode Island, Vermont and Washington.²

In addition, ICE has a list of **697 jails** that is has labeled "limited" and "non-cooperative institutions"; under HR 32, the municipalities where these jails are located stand to lose eligibility for federal funding – for completely unrelated services, and even when the city has not passed a "sanctuary" measure and in no way identifies as a "sanctuary city."

Below we breakdown ICE's jail list by congressional district, to illustrate the impact of HR 32. However, there are many cities not listed by ICE (and thus not included below) that could also be threatened by the heavy hand of the Trump administration, using this bill, e.g. because of their failure to share with the administration sensitive data on residents – including undocumented students seeking in-state tuition.
