


#### A. Overview

# A. Facility Address & Information

GEO proposes using **(b)(4)** bed housing units, currently dedicated to IC use, at the 1,900-bed Rio Grande Processing Center, located in Laredo, TX. The site is strategically situated close to all necessary facility and resident support services. The Facility currently houses up to **(b)(4)** E residents under an agreement with the U.S. Marshals Service (USMS). GEO proposes the continued use of these **(b)(4)** eds for ICE, along with appropriate support space. The two populations will continue to be housed separately, and operational activities will be scheduled to maintain appropriate separation between the two. The **(b)(4)** square-foot Rio Grande has a manned guardhouse, cameras, and security fencing around the perimeter.

This Facility is capable of providing detention management, medical, and transportation services, as well as all support services necessary to meet the needs of adult male ICE noncitizens in compliance with ICE National Detention Standards (NDS) 2019 and Performance Based National Detention Standards (PBNDS) 2011, with some modifications.

The existing Facility currently meets Department of Justice (DOJ) Prison Rape Elimination Act (PREA) requirements and can be modified to also incorporate DHS PREA requirements.

#### G. Audits (Inspections)

GEO's Quality Control Plan dictates that all major functional areas of the facility be audited regularly by the corporate Contract Compliance (CC) department and by facility staff. These audits will be dedicated to ensuring all GEO internal policies and the client required standards are met. Following an initial pre-operational audit, an annual corporate audit reviewing the full scope of services will be conducted by a team of auditors chaired by CC. A second-tier review, the GEO facility internal audits, is conducted by the facility's subject matter experts using pre-identified GEO and client audit tools, with monthly audits targeting all functional areas on a rotating basis throughout the calendar year.









#### B. Facility Background

GEO designed, built, and opened the Facility in 1997 under a contract with the Michigan Department of Corrections to accommodate state inmates with a capacity of 570 beds. In 2005, due to lack of state funding, operations at the facility were discontinued. In 2009, a significant expansion provided 1,225 additional beds, as well as supplementary support areas, recreation spaces, and dining halls with food service. Between 2011 and 2018 additional renovations increased the facility capacity to its current 1,810 general population beds with 100 restrictive housing unit beds. The Facility has provided services to various government clients. Most recently, the Facility housed a low security criminal alien population on behalf of the Federal Bureau of Prisons (BOP) from 2019 to 2022.

#### C. Facility Description

The existing facility can accommodate up to 1,810 ICE residents, including the provision of security, health care services, food service, laundry, utilities, administrative support services, and transportation consistent with ICE's requirements. (b)(4)




