Dear Mr. Hogle:

This letter responds to your October 25, 2024 Freedom of Information Act ("FOIA") request to the Office of Legal Counsel ("OLC") on behalf of the American Civil Liberties Union and American Civil Liberties Union Foundation (together, the "ACLU"), seeking 20 OLC "final opinions, letters, memoranda, and manuals . . . relating to the President's authority to deploy military and national guard troops within the United States, and the activities in which those personnel may or may not engage." As you know, your request was assigned tracking number **FY25-023**. Pursuant to 28 C.F.R. § 16.5(b), your request was processed in the "simple" processing track.

We have completed our search and identified 18 responsive records. We did not identify any records responsive to entry #18 in your request. We have determined that entry #19 in your request seeks a record originating in the Office of the Deputy Attorney General. Pursuant to 28 C.F.R. § 16.4(c) and *FOIA Post, OIP Guidance: New Requirement to Route Misdirected FOIA Requests*, http://www.justice.gov/oip/foiapost/2008foiapost31.htm (updated July 28, 2021), we have re-routed that part of your request to the Office of Information Policy ("OIP") for searching and direct response to you. Of the 18 records located, we have enclosed 16 records here in full. We have referred the remaining two records to OIP for processing and direct response to you. You have the right to an administrative appeal. You may administratively appeal by writing to the Director, Office of Information Policy ("OIP"), United States Department of Justice, 441 G Street, NW, 6th Floor, Washington, D.C. 20530, or you may submit an appeal through OIP's FOIA STAR portal by creating an account following the instructions on OIP's website: https://www.justice.gov/oip/submit-and-track-request-or-appeal. Your appeal must be postmarked or electronically transmitted within 90 days of the date of my response to your request. If you submit your appeal by mail, both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."
