This letter represents the acknowledgement and final response to your Freedom of Information Act (FOIA) request dated February 7, 2025. Your request was for information regarding access to sensitive agency records by individuals associated with the so-called Department of Government Efficiency ("DOGE").

Please be advised your request was submitted to the SAMHSA's Office for Management Technology and Operations for processing. This center informed us that there are no records associated with this request. Based on the information you provided to us, we were not able to locate any responsive records subject to the FOIA. Therefore, we are closing this request.

The U.S. Department of Health and Human Services policy calls for the fullest responsible disclosure consistent with the requirements of administrative necessity and confidentiality as recognized by the FOIA, 5 U.S.C. § 552 and HHS' FOIA regulations at 45 CFR Part 5.

While we believe that an adequate search of the appropriate files was conducted for the records you requested, you have the right to appeal our "No Records" determination. You can appeal and preserve your rights under FOIA and give the agency a chance to review and reconsider your request and the agency's decision.
