Regarding your inquiry to Garrett date March 6, 2007, for the PA State Police:

They are interested in finding a way to use LPRs or photo radar in construction zones. Do you have any information on that?

No information received.

Guidelines for position patrol cars in construction zones? The LT Col wants to position them facing traffic instead of in the same direction. He believes members will be afforded better crash protection should their vehicle be struck by a passing motorist.

I have attached policy and guidelines received. I have also included the point of contact for each responding agency.

## Highway construction work zones?

• Vehicle placement in construction zones would be the same as for any road restriction or closure. AZ DPS allows the patrol vehicle to face oncoming traffic. Section V.G, page 5-1, relates information regarding when the patrol vehicle is parked facing traffic.

- Any CHP personnel working in COZEEP/MAZEEP or any other construction or maintenance detail shall not position their patrol vehicle directly behind a stationary or mobile vehicle equipped with a truck mounted attenuator.
- During the pre-job safety meeting conducted prior to entering the work zone, CHP personnel shall
  agree upon and have a clear understanding of their respective on-site duties. If CHP personnel
  determine the requested vehicle placement to be unsafe, their concerns shall be immediately
  addressed with the Caltrans Field Supervisor. If safety concerns are not resolved, the CHP supervisor
  shall be notified immediately.

Do you allow patrol vehicles to be positioned facing oncoming traffic in highway construction work zones or along side the roadway while on stationary or observation patrol?

- Officers monitoring traffic from the side of the roadway shall not use the technique of parking on the wrong side of the highway facing oncoming traffic.
- Parking in the center median to monitor traffic for any reason, including radar use is discouraged. However, there may be situations where it becomes necessary. For example, enforcing high occupancy vehicle (HOV) lane laws.
  - 1. Monitoring traffic from the center median requires Division approval, and requests will be reviewed and approved on a case-by-case basis.
  - 2. Officers shall not face the wrong direction while monitoring traffic from the center median.
  - 3. Officers shall maintain reasonable, continuous patrol of their assigned beats. Traffic collision trends by hour of day and location may require officers to concentrate on specific portions of their beats during periods of high traffic collision frequency.

- NJSP does not allow patrol vehicles to be positioned facing oncoming traffic in highway construction
  work zones and/or along side the roadway while on stationary or observation patrol. And although the
  NJSP does not have any specific policy with regard to vehicle positioning in construction work zones,
  our training program recommends where to be positioned and does give latitude.
- Specifically, members may position their cars in advance of the work zone, in the work zone (near the activity area) or after the work zone. The NJSP recommends looping the zone often.

• Our deputies are trained to park their cars in such a way that it blocks them or other emergency workers from being struck by an approaching car. When our deputies are employed to work construction zones, they are usually positioned by the employer.

• Construction Zones – Emergency Vehicle Turn Around may sit at 90 degree angle to roadway or if median were wide enough on occasion may monitor traffic flowing in both directions.

• Troopers position their vehicles in the position that will allow the most visibility and protection for both the Trooper and the construction workers.
