Here is a synopsis of what I have obtained so far. The caveat is that the airborne missions are not recorded in [redacted] metrics. I also cannot locate any data in Sentinel and [redacted]. Therefore, the data I have is based upon an urgent email request that was sent out to the field [redacted]. There may be additional missions that can be reported in the future, when all the [redacted] respond (the email was sent 06/08/2015). Also, some of the missions might go back as far as [redacted] when [redacted] had tried to start a nascent aerial capability. At that time, CSS gear was sent to [redacted] and [redacted] had gear, but they sent it back for lack of interest/usage. The POC for that program, [redacted] reached out specifically to those offices in addition to the [redacted] wide email I sent. All offices reported back with the same stats as the ones emailed to me. There may also be airborne missions that involved [redacted] that are no longer in the [redacted] so I cannot say for certain that the mission numbers are 100% accurate. So far, we have five airborne missions reported.

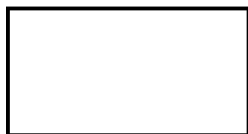

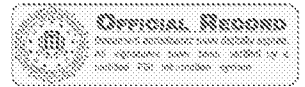
