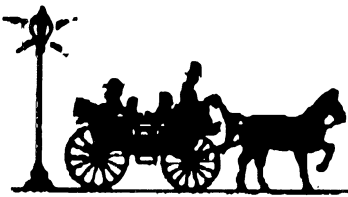
The following is a response to your OPRA request, dated, September 21, 2012.

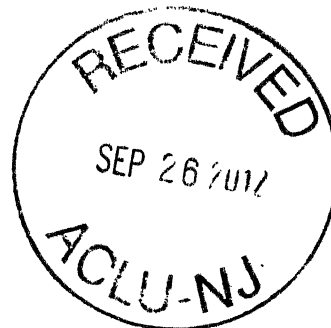
