Re: Public Records Act Request Response Regarding Automatic License Plate Readers (LPR)

Dear Mr. Conley:

The Milpitas Police Department is in receipt of your public records request, dated July 31, 2012 and received on August 1, 2012. It is our understanding that you have requested information as it relates to our existing LPR equipment, the collection of data, retention, access, and data storage.

The Milpitas Police Department possesses four PAGIS LPRs from PIPS Technology, two Remington ELSAG LPRs and two stationary LPRs from Remington.

The four PAGIS LPRs were purchased with grant funds provided through The Citizen Options for Public Safety 2008 grant, the 2009 American Recovery and Reinvestment Act (ARRA) Edward Byrn Justice Assistance Grant (JAG), the Citizen Options for Public Safety 2010 grant and the 2010 JAG grant. The retained staff work, invoices and government approval for the PAGIS LPRs is attached to this document. The attached documents contain the make and model of the LPRs.

The four Remington items were purchased through the Buffer Zone Protection Plan Program through the United States Department of Homeland Security. These items were purchased for the physical protection of critical infrastructures and key assets. I concluded that the release of some documents supporting the purchase of these items would compromise the security of critical infrastructures and will not release them. I have, however, provided equipment tracking forms for the purchase of these items and the tracking forms contain the make and model of these items.

We do not have any requests for proposal for these purchases. Our staff researched existing technology and provided purchase recommendations. A document reviewed during this research was produced by the U.S. Department of Homeland Security and is provided to government agencies for administrative use only. You may contact the U.S. Department of Homeland Security / Federal Emergency Management Agency, IMSI Division – E Street, ATTN: SAVER Program, 500 C Street SW, Washington, DC 20472 for any questions regarding the release and / or contents of the document.

Six of the LPRs are affixed to marked patrol cars and are deployed throughout our city. The two stationary LPRs are housed within the Milpitas Police Department and are not deployed regularly. In 2011, our six LPRs captured 2,031,435 license plate images. This was an average of 169,286 license plates per month. As of August 2, 2012, the Milpitas Police Department's LPRs have captured images of approximately 4,714,000 license plates.

The LPRs store date and time of image capture, the reader identification, vehicle photo (if captured), license plate photo, latitude and longitude. All data is housed in a secure database with restricted access and the data is not purged.

The PAGIS LPRs are dual-lens cameras that capture both color and black and white images with real-time recognition of characters in the license plate images. The PAGIS LPR takes three photos in varied shutter speed and uses the highest quality image. I do not possess the technical capabilities of the Remington products.

The Milpitas Police Department uses LPRs to locate stolen vehicles, lost or stolen license plates and felony wants associated to license plates. The data used for the three categories is retrieved from a State of California Department of Justice database. Internal use of this technology is for law enforcement investigations only and may not be accessed for unofficial use. The Milpitas Police Department's sworn peace officers and dispatchers are authorized to access the LPR database. We do not possess a system that records who is accessing the data, when it is accessed or written policy on the use of LPRs.

Over the past two months, the Milpitas Police Department has been working with the Santa Clara County Sheriff's Office on delivering LPR data to the Sheriff's Office (SO) database. These efforts have been to attempt to establish a connection with the SO with the intent to share data. These efforts were a result of a verbal agreement and no Memorandum of Understanding exists. This data has been shared with the SO information technology staff only for test purposes and is not being delivered to their sworn field deputies.

The Milpitas Police Department does not possess any additional written or verbal agreements to share its data. We have, however, had contact with the National Vehicle Location Service and periodically requested information from their database for criminal investigations.

Re: Public Records Act Request regarding Automatic License Plate Readers

Dear Chief Graham:

This letter is a request under the California Public Records Act (California Government Code §6250 et seq.) by the American Civil Liberties Union of Northern California. This request seeks records <sup>17</sup> regarding automatic license plate readers (ALPRs). ALPRs are also sometimes referred to as Automatic Vehicle Identification, Car Plate Recognition or License Plate Recognition equipment and/or software. This records request uses ALPR in reference to any of this technology.

#### Records Requested

Please provide copies of the following records created from January 1, 2006 to the present:

- All records regarding your policies, practices and procedures for procuring and using ALPR technology, and for storing, accessing and sharing data obtained through ALPR technology;
- 2. All records regarding the procurement of ALPR technology, including
  - a. any needs assessment or other analysis of the decision to procure ALPR technology;
  - b. the number of ALPR units or systems acquired;
  - c. sources of funds used to pay for ALPR technology;
  - d. invoices for the purchase of ALPR technology;
  - e. local government approval for any ALPR purchase;

- f. requests for proposal (RFP) for the procurement of ALPR technology and bid documents submitted in response;
- g. analysis or review of responses to any RFP;
- h. interactions with vendors, suppliers and potential suppliers of ALPR technology, including materials and fact sheets supplied by vendors describing their products;
- i. make, model, and manufacturers' specifications and instructions for ALPR unit(s) ultimately procured by your agency
- 3. All records regarding the use of ALPR technology, including
  - a. the number of vehicles equipped with ALPR technology;
  - b. for stationary deployments, the number and physical location of ALPR units;
  - c. the technical capabilities of the ALPR units;
  - d. what types of data are obtained by the use of ALPR units;
  - e. the purposes for which data obtained by the use of ALPR units are used;
  - f. the number of license plates scanned and/or read in a given time period (day, month, year, etc.);

8. All training materials used to instruct members of your agency in ALPR deployment and use, data management, or operation of automated records systems that contain ALPR data to which any member of your agency has access, including regional or shared ALPR databases.

Because this request is on a matter of public concern and because it is made on behalf of a non-profit organization, we request a fee waiver. See North County Parents Organization v. Dept. of Educ., 23 Cal. App 4th 144 (1994). We are also requesting documents to be provided in electronic format if at all possible. Doing so would eliminate the need to copy the materials and provides another basis for our requested fee waiver. If, however, such a waiver is denied, we will reimburse you for the reasonable cost of copying. Please inform us in advance if the cost will be greater than \$50.

According to the California Public Records Act (California Government Code §6253(c)), a response is required within 10 days. Thank you for your prompt attention to this matter. Please furnish all applicable records to the undersigned at 39 Drumm Street, San Francisco, CA 94111 or cconley@aclunc.org. #### **ISSUE:**

How shall the Milpitas Police Department spend state grant funds (Fiscal Year 2008) allotted by Citizen Options for Public Safety?

#### BACKGROUND:

The City of Milpitas received COPS funds from the state pursuant to Government Code 30061, in the amount of \$128,004. These funds must be used to support front line law enforcement services and must supplement and not supplant existing funding for front line law enforcement services. No city matching funds are required.

These funds shall be appropriated pursuant to written request from the Chief of Police of the law enforcement agency that provides police services for the city. The request shall specify the front line law enforcement needs of the requesting entity including the personnel, equipment and programs that are necessary to meet those needs.

After convening a public hearing before the City Council, the funding will be evaluated by the Supplemental Law Enforcement Oversight Committer (SLEOC) as required by law.

We are recommending that the funds be used to finance the following:

#### DISCUSSION:

The estimated costs of the requested items as outlined below include tax and shipping:

Alert Line Enhancement to CAD. This is a new module to our Computer Aided Dispatch (CAD) system. This new module will alert dispatchers to any priority messages or changes to an existing CAD event. Important changes include Upgrade/Downgrade in Priority, change of address or location, and any urgent message such as "man with a gun" or "suspect is approaching the building." The module will alert the dispatcher visually and audibly with an alert tone via the Alert Line module and allow the dispatcher to open/view the event by selecting the Alert Line message. \$17,000

Automated License Plate Reader. This technology has proven to be an invaluable investigative tool responsible for the recovery of stolen vehicles, disproving fictitious alibis and locating sex offenders who are out of registration compliance. \$24,000

Chemical Agents. Chemical agents are used during training scenarios, SWAT operations as well as for unruly crowd control and dispersal. In accordance with our department chemical munitions purchase plan, our current supply of the chemical agents will be depleted due to upcoming expiration dates. The purchase will allow for a new supply of chemical agents to be rotated into stock and be available for immediate deployment.

Child ID System for fingerprinting (2). The system (@ \$4,302 each) is all-inclusive and allows our Senior Volunteers the ability to provide free child identification fingerprinting to children. The two new systems, with faster processing capacity, will allow volunteers to more quickly process each child at various events throughout the city. The current systems would remain stationary at the Great Mall Storefront and in the Command Van.




CrashZone Training. The CrashZone accident diagramming system, which includes software, a laser rangefinder and other accessories that allow for accurate measurements and efficient diagramming of fatal and injury accidents and major crime scenes, was previously purchased through grant funding. Second-stage training in the amount of \$3,300 will focus on forensic mapping of crime scenes and court presentation of evidence.

#### Digital Evidence Photo Software.

Several years ago the Police Department transitioned from standard 35mm film photography to digital photography as the technology improved to the point where it was widely accepted by the courts. Currently we store digital images on a desktop computer very similar to the way consumer photos are stored at home. Because of the proliferation of digital evidence over the last few years, the police department now finds itself in need of a photographic management system capable of indexing, cataloging, storing, retrieving and duplicating this evidence while also creating the required audit trail to determine who has viewed, printed or, in adjudicated cases, deleted photographic evidence.

cost recovery. Ms. Joki displayed a chart comparing Milpitas to four other cities in Santa Clara Valley, showing Milpitas in the median for hourly rates for inspection.

Mayor Esteves inquired specifically about why the City of Palo Alto's rate was \$113 per hour, and how that differed from Milpitas. Chief Frank responded that the turnaround time and quality of services varied a lot. The Mayor further asked whether costs went up 40% since 2003 and about other cities in the County that were non-full cost recoverable, but were subsidized by the General Fund.

Councilmember Gomez asked about the outreach effort done on the proposed rates and any feedback from the Chamber of Commerce. The Fire Marshal responded that the Chamber did not take a position one way or another with regard to the fee. Mr. Gomez further asked about staffing and if the model was based on full staffing. Ms. Joki noted that work was accomplished with some contract staff at this time and the contracted workers would not be needed if there was full staffing. She noted also that plan review turnaround time was very good in Milpitas.

Councilmember Gomez asked the City Manager if all the various rate increase proposals could come all together in one meeting. City Manager Williams responded that the City staff, in the future, would bring all proposed fee adjustments at the same time, as a Master Fee Schedule.

Councilmember Polanski noted that in 2003, there had not been a rate increase in eight years, and even then, the Council did not go to full cost recovery. She asked about incremental rate changes and whether those were considered.

Mayor Esteves re-opened the public hearing for comments.

**Isaac Hughes** asked for clarification in the method of calculation. Fire Department staff responded to him directly.

Vice Mayor Livengood was in agreement with the philosophy of full cost recovery, and trusts the staff work on the explanation. Mayor Esteves stated he was generally for cost recovery, but believed it was more important to make the City a competitive one for business, especially for economic development purposes.

Councilmember Gomez asked about the taser with cameras (on the list of equipment to purchase). Commander Pang explained how those tools operated, and stated they were for better accountability with recording video and audio.

Vice Mayor Livengood asked for an explanation of the term "Rifle Magazines" on the list. Staff noted these were more commonly known as a "clip," a device that holds multiple rounds of gun ammunition in a rifle.

Councilmember Giordano wondered if there was a priority level in order to the list and Ms. Pang responded no, the nine items were not listed in any priority.


She reviewed the scope of services. Rate adjustments were made by a contract-specified formula, which she detailed. One new cost added was street sweeping, now being done by Allied.

#### ISSUE:

How to spend the 2009 American Recovery and Reinvestment Act (ARRA) Edward Byrne Justice Assistance Grant (JAG) allocation of \$73,137.00?

#### **BACKGROUND:**

On February 17, 2009, President Barack Obama signed into law the American Recovery and Reinvestment Act (ARRA) of 2009, Public Law 111-5 (the "Recovery Act"). The Act includes almost \$2 billion in critical resources for state and local law enforcement activities through the Justice Assistance Grant (JAG) program.

On April 21, 2009, the County of Santa Clara agreed to coordinate a joint application among several law enforcement agencies in the County, including the Milpitas Police Department, and the joint application was submitted to the United States Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, on May 18, 2009.

On June 9, 2009, the joint application was approved, and the grant was awarded (Project # 2009-SB-B9-0976). The portion of the grant allocated to the Milpitas Police Department is \$73,137.00, and a draft resolution to formally accept the grant has been prepared for the City Council Meeting on August 4, 2009.

#### **DISCUSSION:**

The grant does not require matching funds, but it does require strict adherence to timely reporting requirements and the establishment of a separate trust fund to track all expenditures. The grant is intended to enhance the front-line delivery of services through existing programs by obtaining the necessary equipment.

The proposed ten (10) grant expenditures are as follows:

#### 1. License Plate Reader (LPR) System (\$24,000):

The LPR systems use technology to have cameras read license plates and automatically conduct computer checks to determine if the license plate is associated to a stolen vehicle, a wanted vehicle, or other vehicle of special interest. Officers can also manually enter the license plate numbers of vehicles under current investigation but do not meet the requirements for entry into the state and national databases for wanted vehicles. Officers have also used the LPR systems to track the vehicles of registered sex offenders. In the two years that the Milpitas Police Department has used the LPR systems, we have recovered about sixty (60) wanted vehicles, including the recovery of a vehicle that lead to the arrest of a homicide suspect. The addition of another LPR system would enable more officers to use the technology.

#### 2. Tasers (14 units $\times$ \$1,400 each = \$19,600):

The Milpitas Police Department currently uses the Taser X26 with the Taser Cam. Although the most obvious advantage of having Tasers available is as an alternate level of force, the Taser Cam has greatly enabled us to objectively determine the circumstances under which the Taser was deployed. It has helped us identify training issues and address the potential use of force concerns. Because of our limited inventory of Tasers, officers currently share a pool of Tasers. In order to ensure that every uniformed officer always has a Taser available, we would like to individually issue one to each officer. The addition of fourteen (14) Tasers will enable us to reach the goal.

#### 3. Taser Cartridges (150 units x \$23 each = \$3,450):

The Tasers in our inventory utilize Taser Cartridges, which have a five (5) year warranty. The technology of Taser cartridges has also improved in the last five years. The addition of one hundred fifty (150) Taser Cartridges will enable us to replace our existing inventory that is expiring and enable us to continue practical training and qualifications in order to maintain proficiency.



The City of Milpitas anticipates receiving COPS funds from the state pursuant to Government Code 30061, in the amount of \$109,707. These funds must be used to support front line law enforcement services and must supplement and not supplant existing funding for front line law enforcement services. No city matching funds are required.

These funds shall be appropriated pursuant to written request from the Chief of Police of the law enforcement agency that provides police services for the city. The request shall specify the front line law enforcement needs of the requesting entity including the personnel, equipment and programs that are necessary to meet those needs.

After convening a public hearing before the City Council, the funding will be evaluated by the Supplemental Law Enforcement Oversight Committee (SLEOC) as required by law.

Below are recommended expenditures for COPS grant monies for fiscal year 2010, including tax and shipping, as applicable:

1. Equipment to Support Use of New Pistols	\$26,000
2. Uniforms and Supplies for Volunteers	\$3,000
3. Parent Project	\$9,000
4. License Plate Reader System	\$35,000
5. Crime and Accident Scene Software Training	\$3,500
6. Digital Cameras for Officers' Use	\$8,000
7. Multi-Chargers for Charging Radio Batteries	\$2,000
8. Window Tint Meters	\$1,000
9. Collapsible Traffic Cones	\$3,307
10. SWAT and Tactical Team Equipment	\$4,500
11. Patrol Rifles .	\$14,400

Further specifies on these spending areas are as follows:



Equipment to Support Use of New Pistols. We currently have a pistol replacement project where Smith & Wesson has offered to exchange our current SW99 duty pistols for new SW M&P duty pistols. Officers have been using the SW99 pistols since June of 2000, but Smith and Wesson will no longer manufacture or support the SW99 for law enforcement uses. Certain parts of the pistol are not withstanding the rigors of law enforcement use and require more frequent replacement. Parts are becoming increasingly difficult to acquire. The M&P pistol is more durable as it was specifically designed for military and police use. The specified amount will cover costs for duty holsters, concealable holsters, magazine pouches, light attachments compatible with the new pistol, and plastic training guns.

Uniforms and Supplies for Volunteers. The Police Community Relations Unit oversees our volunteer program, which includes Citizen Volunteers and Police Explorers. Members of these groups are required to wear uniforms at their personal expense. Some of our volunteers are on fixed or limited incomes, and others are youths who are full-time students. The specified amount will allow for the purchase of uniforms for the members of these two groups, as well as the necessary supplies for volunteers to continue offering complementary child identification fingerprinting to children. \$3,000

Parent Project. Parent Project is a program with proven results offered by the Police Department for parents dealing with challenging teens. The funding would provide for course materials, light snacks for the attendees, and for the overtime salaries of two officers to facilitate the 12-week program.

License Plate Reader. The Police Department currently has four vehicle-mounted LPR systems. The LPR systems use technology to have cameras read license plates and automatically conduct computer checks to determine if the license plate is associated to a stolen vehicle, a wanted vehicle, or other vehicle of special interest. Officers can also manually enter license plate numbers of vehicles under current investigation that do not meet the requirements for entry into the state and national databases for wanted vehicles. In the approximate three years that the Police Department has used the LPR systems, we have recovered about seventy (70) wanted vehicles, including the recovery of a vehicle that lead to the arrest of a homicide suspect. The addition of another LPR system would enable more officers to use the technology. The specified amount will allow for the purchase of one LPR, a new server for the data storage, and a sequel license (required software).

Crime and Accident Scene Software Training. The Traffic Safety Unit officers and Field Evidence Technicians are becoming more proficient with the digital mapping equipment purchased with the COPS 2009 grant. The data collection is an important primary function, and the use of our existing CrashZone software to transfer the data into diagrams that can withstand the scrutiny of any judicial proceeding is vital. These diagrams save officers a tremendous amount of time as compared to drawing them by hand. And, they offer a wider array of methods to view the diagrams, including in three dimensions and from different vantage points. The specified amount will permit for the training of select Traffic Officers and Field Evidence Technician Officers with the CrashZone hardware and software.

\$3.500

Digital Cameras for Officers' Use. Officers in Patrol currently share a pool of about six (6) digital cameras. Because of overlapping shifts, there are not always cameras available during an officer's shift. The existing digital cameras are reaching the end of their useful life expectancy. Rather than purchasing additional pool digital cameras, it would be beneficial to assign a digital camera to each patrol vehicle so that the digital cameras are always available in the field. The specified amount will allow for the purchase of 28 cameras, SD memory cards, rechargeable AA batteries and durable cases.



JAG funding is a formula based on population and crime statistics, in combination with a minimum allocation to ensure that each state and territory receives an appropriate share. Government Code section 30061 requires a public hearing regarding the expenditure of the grant. Government Code section 30062 specifies that these funds must be used exclusively for front line law enforcement services, including technical assistance, training, personnel, equipment, supplies, contractual support, and information systems for criminal justice. The grant funds must supplement and not supplant existing funding for front line law enforcement services. These funds shall be appropriated pursuant to a written request from the Chief of Police of the law enforcement agency that provides police services for that city. The request shall indicate the front line law enforcement needs of the requesting entity including the personnel and equipment that are necessary to meet those needs.

The 2010 allocation for the City of Milpitas is \$18,517. No city matching funds are required.

These funds will be allocated upon acceptance and approval of the on-line grant application, pending review by the City Council. The spending plan shall also be available for public review.

The spending plan will be presented during a public hearing at the August 3, 2010 City Council meeting.

We are recommending that the funds be used to finance the following:

1. License Plate Reader System

\$18,512

Further specifics on this spending area are as follows:

License Plate Reader. The Milpitas Police Department currently has five vehicle-mounted LPR systems. The LPR systems use technology to have cameras read license plates and automatically conduct computer checks to determine if the license plate is associated to a stolen vehicle, a wanted

vehicle, or other vehicle of special interest. Officers can manually enter license plate numbers of vehicles under current investigation that do not meet the requirements for entry into the state and national databases for wanted vehicles. In the approximately 4 years that the Police Department has used the LPR systems, we have recovered about eighty (80) wanted vehicles, including the recovery of a vehicle that lead to the arrest of a homicide suspect. The addition of another LPR system would enable more officers to use the technology. The specified amount will allow for the purchase of one LPR.

#### **RESOLUTION NO. 8015**

The grant funds must supplement and not supplant existing funding for front line law enforcement services. These funds shall be appropriated pursuant to a written request from the Chief of Police of the law enforcement agency that provides police services for that city. The request shall indicate the front line law enforcement needs of the requesting entity including the personnel and equipment that are necessary to meet those needs.

The 2010 allocation for the City of Milpitas is \$18,517, with no city matching funds required. Police staff request the designated allotment be used to fund a License Plate Reader (LPR) purchase.

<u>Fiscal Impact</u>: None. The \$18,517 JAG grant will fully cover the costs of the License Plate Reader.


