As the Special Agent in Charge of the Sacramento Division of the FBI, I am pleased to invite you to participate in our Citizens Academy Class of 2004. Attendance is limited to 25 participants. Class participants come from the business, educational, civic, and public sectors throughout the various communities we serve. I hope you will elect to join us in this very interesting and enjoyable endeavor.

The idea for a Citizens Academy originated in the Phoenix Division of the FBI in 1993 as part of the FBI's Community Outreach Program and this will be the first Citizens Academy hosted by the Sacramento Division.
