Synopsis: (U) This Organized Crime Domain Intelligence Note is for the purpose of planning and intelligence analysis to facilitate investigative activities to detect, obtain information about, prevent, or protect against federal crimes or threats to the national security posed by organized crime in the Detroit Division's AOR. Activities that may be carried out as part of this process include collecting information to improve or facilitate "domain awareness" and engage in "domain management.

Details: (U) The 2008 Attorney General Guidelines for Domestic FBI Operations authorizes the FBI to "engage in planning and intelligence analysis to facilitate investigative activities to detect, obtain information about, prevent, or protect against federal crimes or threats to the national security." Activities the FBI may carry out as part of this process include collecting information to improve or facilitate "domain awareness" and engage in "domain management."
