The North Texas Auto Theft Task Force does not have a written policy for the use of the ALPR, storing, accessing and sharing data obtained through ALPR technology.

FY 2008 ALPR used to read 323,213 License Plates and to recover 147 stolen vehicles.

Fy 2009 ALPR used to read 1,167,903 License Plates and to recover 221 stolen vehicles .

Fy 2010 ALPR used to read 1,016,762 License Plates and to recover 177 stolen vehicles.

Fy 2011 ALPR user to read 906,566 License Plates and to recover 109 stolen vehicles.

The North Texas Auto Theft Texas Auto Theft task force acquired 3 ALPR units and 1 ALPR was donated by the National Insurance Crime Bureau and 1 donated by PIPs technology for a total of 5 ALPR units.

Five vehicles are equipped with ALPR units

The North Texas Auto Theft Task Force does not use stationary units.

The North Texas Auto Theft task Force use the ALPR units to recover stolen vehicles only.
