Re: Public Records Act Request Dated July30, 2012

Dear Mr. Conley:

This letter is in response to your public records request dated July 30, 2012, which was directed to the attention of Craig Steckler, Chief of the Fremont Police Department (Department) for disclosable records related to automatic license plate readers (ALPRs) used by the Department.

To the extent that the request seeks documents containing information gathered, or about the gathering of information, through the use of surveillance technology, responsive records, if they exist, would be part of an individual criminal investigation case file or intelligence file. These records would be exempt from disclosure under Government Code Sections 6254(f) and 6254(k) and under Evidence Code Sections 1040(b)(2) and 1041.

To the extent the request seeks records that are not part of an individual criminal investigation or intelligence file but would reveal the Department's technical surveillance capabilities by disclosing information about those capabilities, such as records that show the type, number and specifications of surveillance resources, the sources of the surveillance resources, and the circumstances of interagency and business cooperation, the Department objects to the requests. Disclosure of this information to the public would allow individuals to defeat or avoid the Department's efforts regarding surveillance, property recovery, and apprehension of fleeing suspects. This information is exempt from disclosure under Government Code Sections 6254(k) and 6255, and Evidence Code Section 1040(b)(2).

To the extent the request seeks documents that are copyrighted work or contain copyrighted work, federal law limits the reproduction by the City under the Copyright Act, 17 USC § 101 et seq. The City requires a waiver or permission from the copyright owner before reproducing copyrighted works. To the extent the request seeks documents containing business or industry information protected by the trade secret privilege, the City cannot disclose the information pursuant to Civil Code §3426.1.



Notwithstanding the foregoing, the Department has located documents that the Department believes may be responsive to your request or of interest to you that the Department can disclose.

Request No. 1. All records regarding your policies, practices and procedures for procuring and using ALPR technology and for storing, accessing and sharing data obtained through ALPR technology.

The City has records which are not exempt from disclosure as a public record under Govt. Code Section 6254 and are responsive, specifically, Policy 462.

Request No. 2. All records regarding the procurement of ALPR technology, including;

a) any needs assessment or other analysis of the decision to procure ALPR technology.

The City has records which are not exempt from disclosure as a public record under Govt. Code Section 6254.

b) the number of ALPR units or systems acquired.

One unit to outfit one vehicle

c) sources of funds used to pay for ALPR technology.

General fund monies

d) invoices for the purchase of ALPR technology.

The City has records which are not exempt from disclosure as a public record under Govt. Code Section 6254.

e) local government approval for any ALPR purchase.

The Chief of Police approved the ALPR purchase.

f) requests for proposal (RFP) for the procurement of ALPR technology and bid documents submitted in response.

The City has no records which are not exempt from disclosure as a public record under Govt. Code Section 6254.

g) analysis or review of responses to any RFP.

The City has no records which are not exempt from disclosure as a public record under Govt. Code Section 6254.

h) interactions with vendors, suppliers and potential suppliers of ALPR technology, including materials and fact sheets supplied by vendors describing their products.

The City has no records which are not exempt from disclosure as a public record under Govt. Code Section 6254.

i) make, model, and manufacturers' specifications and instructions for ALPR units(s) ultimately procured by your agency.

Request No. 4. All records regarding the storage of data using ALPR technology, including;

a) What types of data are stored for any period longer than an hour.

License plate and when functioning, the GPS location of the license plate.

b) How long data is stored.

c) When data must be discarded.

d) How many individual license plate scan records your agency currently stores.

An internal City database.

c) Third parties, governmental or private, that may access your agency's ALPR data, including what procedures third parties must go through in order to access the data and any restrictions placed on third parties regarding further sharing of your ALPR data.

The City has no records which are not exempt from disclosure as a public record under Govt. Code Section 6254.

d) Any agreements to share ALPR data with outside agencies, corporations or other entities.

Request No. 7. All records regarding obtaining ALPR data from third parties, including which database your agency can access.
