I am in receipt of your FOIL request and have reviewed same.

We, here at the police department, try our best to accommodate individual requests for information.

Please be advised that we currently do not have a policy regarding the use of our license plate reader.

In regards to the procurement of our license plate reader(LPR), I have included four pages of documents that I could locate from when it was purchased in 2006. We purchased one LPR in 2006 and it is the only LPR that The City of Newburgh Police Department has ever owned. It is still in use as of this date.


In regards to the storage and sharing of data...We currently do not, nor have we ever had a mechanism in place to store, share and/or retrieve the data.

In regards to training materials...Your request is denied in part. We do maintain documents provided to us by the vendor, ELSAG located at 7 Sutton Place Brewster, NY 10509. However, duplicating and/or disseminating them are prohibited under federal copyright law. Please contact them directly.
