BAIT VEHICLE, STREET RACER & LICENSE PLATE READER WORKING GROUP  
LAW ENFORCEMENT PARTICIPATION AGREEMENT**

WHEREAS, the National Insurance Crime Bureau ("NICB"), the Motor Vehicle Enforcement Division, State of Utah ("MVED"), and various NICB member insurance companies have formed a Bait Vehicle, Street Racer and License Plate Reader Working Group (the "Working Group") as a tool to combat vehicle theft, insurance fraud, and other crimes linked to a license plate in the State of Utah; and

WHEREAS, the law enforcement agency known as UHP  
(the "Agency") desires to participate in the Working Group;

NOW THEREFORE, the undersigned, being an authorized representative of the Agency, agrees as follows:

**1.0 WORKING GROUP CONDITIONS:** The undersigned representative of the Agency agrees that he/she has read, understands and approves all conditions of the Working Group Operational Plan, Vehicle Sub-lease Assignment Agreement, and warrants that his/her Agency will adhere to same at all times during the Agency's participation in the Working Group.

**2.0 TERM AND TERMINATION:** This agreement is binding and shall remain in full force and effect until the Agency no longer wishes to participate in the Working Group or the Working Group's operations are discontinued. Any notice of termination by the Agency shall be given, in writing, to the MVED Official in overall command of the Working Group.

**3.0 ASSIGNMENT:** This Agreement may not be assigned.
