My name is [REDACTED] and I am 23 years old and although my PAST CRIMINAL RECORD isn't at it's best, at heart I'm still a great kid! I WAS violated on my probation back in [REDACTED] and that is when I first experienced the prison world.

I caught a shoplifting charge that was ended in physical contact with me and the store employee. Even though I wasn't really the victim shoplifting I still WAS one of those "ones" who was at the wrong place at the wrong time.

Needless to say I WAS sentenced to 1 year for violation of probation and 4 years for simple robbery and served two 1/2 years in the M.D.O.C. And WAS released [REDACTED] on ERS (EARLY RELEASE SUPERVISION) and there again back hanging with the same friends whom I thought had my best at interest, four months later I WAS back in M.D.O.C. custody for violation of EARLY RELEASE for a shoplifting charge once again @ Belk's clothing store. From then on I WAS sent back to prison to now serve 1 year for shoplifting and 4 years for violation probation and also another 5 years for another county for violation probation. also. So I WAS back in M.D.O.C. [REDACTED] for a sentence of 10 years to serve.

After being locked up for about 6 months I suffered from something many young males would hate to speak on and that's RAPE. I WAS raped at East Mississippi Correctional Facility in Meridian, MS by a [REDACTED], I WAS beat brutally and faced SEVERAL facial and rectum injuries from

THIS ATTACK. I WAS RAPE, KIDNAP, AND ASSAULTED BY SEVERAL [REDACTED]

I WAS HELD HOSTAGE DUE TO THIS ATTACK BY THESE [REDACTED] IN A CELL. I WAS THREATENED WITH KNIVES AND TORTURED BY THESE INMATES FOR SEVERAL HOURS.

I WAS RAPE FROM 11:30 P.M. ON A NITE UNTIL 3:30 A.M. IN THE MORNING BY [REDACTED] A WELL KNOWN [REDACTED]

AS HE RAPE ME CONTINUOUSLY ALL I COULD DO WAS CRY BECAUSE ONE FALSE MOVE AND I KNEW THIS GUY WOULD TAKE MY LIFE. AFTER BEING A VICTIM OF RAPE BY ANOTHER MALE I AM SUFFERING STILL FROM ANXIETY DEPRESSION AND STRESS ISSUES BECAUSE OF THIS ATTACK. I DON'T FAULT MY SEXUALITY BUT I FAULT THE REASONS THAT I'M IN PRISON TODAY. IF I HAD ONE WISH I WOULD WISH THAT I NEVER VIOLATED THE LAW AND SHOPLIFTING WHICH WHAT GOT ME IN PRISON. I'VE ALWAYS HAD WANTED TO LIVE A NORMAL LIFE AND HANG OUT WITH FRIENDS AND ENJOY.

BUT DUE TO THIS TRAGIC INCIDENT THAT HAPPENED TO ME ALL I WANT TO DO IS SPEAK OUT TO OTHERS THAT ARE SUFFERING FROM WHAT I WENT THROUGH ON [REDACTED] AND LET THEM KNOW ITS OKAY TO SPEAK UP AND TELL SOMEONE BECAUSE NO ONE SHOULD BE VIOLATED OF THEIR SEXUAL PERSONAL SPACE.

I WAS HURT VERY BADLY AND SOMETIMES I FEEL LIKE ITS MY FAULT BUT AT THE END OF THE DAY I KNOW IT WASN'T.

AGAIN MY NAME IS [REDACTED] AND I TOO WAS A VICTIM OF RAPE.
