The basis for the document is the New York P&P that I provided to Marlene and Mike. It in turn was based on a handshake between Chuck DeWeese and me re the use of S402 or other funds for LPRs. We agreed to 1/3 participation with Federal funds. We would support the purchase of one unit for every three purchased. After examining the State use program where costs were shared among NHTSA, Justice and State Police, it turned out that NHTSA money has only paid for 15% of the over 500 units in use.

Early monitoring yields that the vast majority of hits are made for suspended/revoked drivers, In Canada, it was 70%.

Still, the wildcard is what the police program the units to look for. In lower NYC, they are looking primarily for certain individuals and stolen vehicles under the assumption that those would be used by terrorists.

I think the one for three ratio is a good one.

The NHTSA document was designed for the regions that are being hit with requests, now. They use NY as an example. NY has more units in use than any other State.

My report on this is in the public directory and in an old e-mail that you may have.

The limitation that our money must be prorated for highway safety use is statutory. Crime reduction is not in our mission nor in our authorizing language. Chief Counsel was very wary of DDACTS because of its emphasis on crime. In fact, even some in Justice felt we were encroaching.
