(b)(6) and I just had a call with (b)(6), an Associate Dean at Penn State University, regarding Penn State's participation in a Blue Campaign student toolkit pilot program. He is the Principle Investigator on a student project examining indicators of human trafficking in Pennsylvania in hopes of raising awareness and identifying networks within the state. The school has been working with the PA State Police and the PA Office of Homeland Security. During our conversation, he asked whether a Blue Campaign representative could attend a Human Trafficking Awareness Seminar hosted by Penn State on January 17 (see attached agenda).

Is this the type of event that (b)(6) could attend as part of her Human Trafficking Month events? PA Senator Stewart Greenleaf will be the keynote speaker and they envisage having a law enforcement and social services panel. If (b)(6) can participate, she could either present on her own or as part of the law enforcement panel. As further background, (b)(6) also indicated that he has collaborated with (b)(6) DHS's CVE coordinator, and (b)(6) Executive Director of the DHS Office of Academic Engagement.
