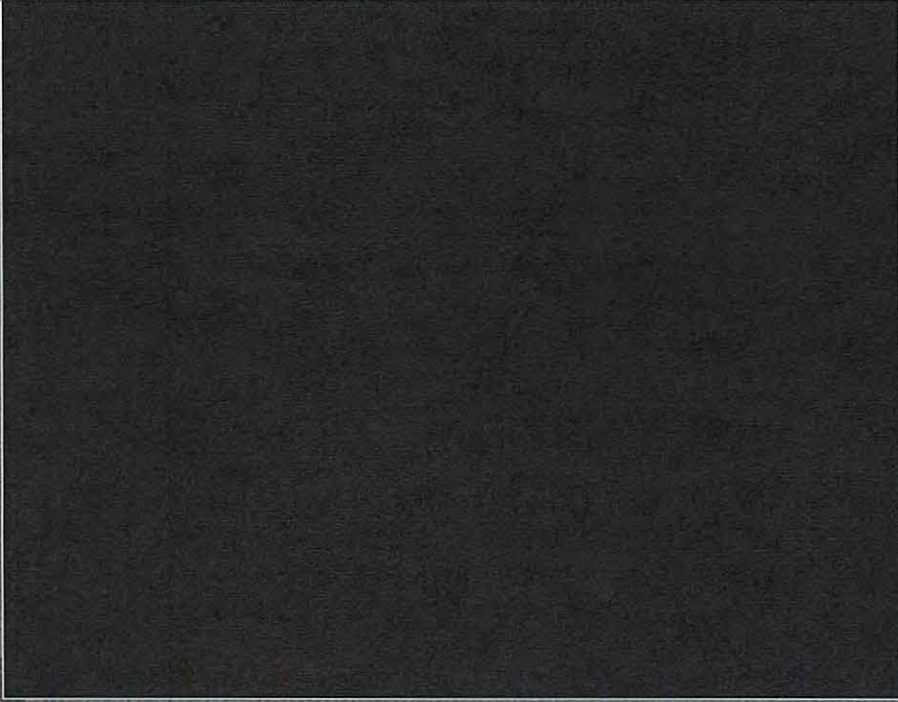

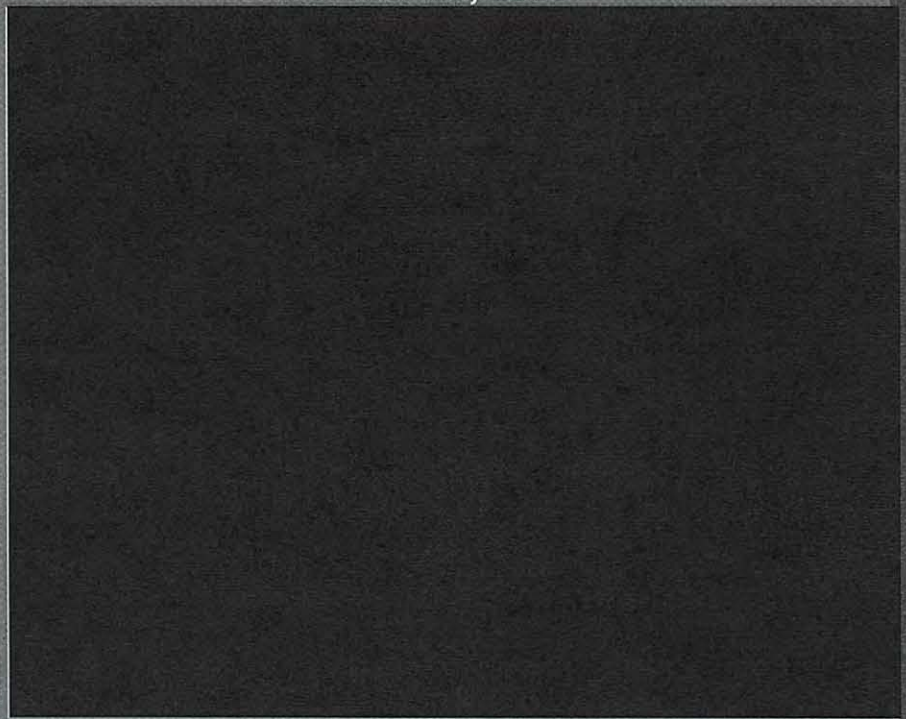

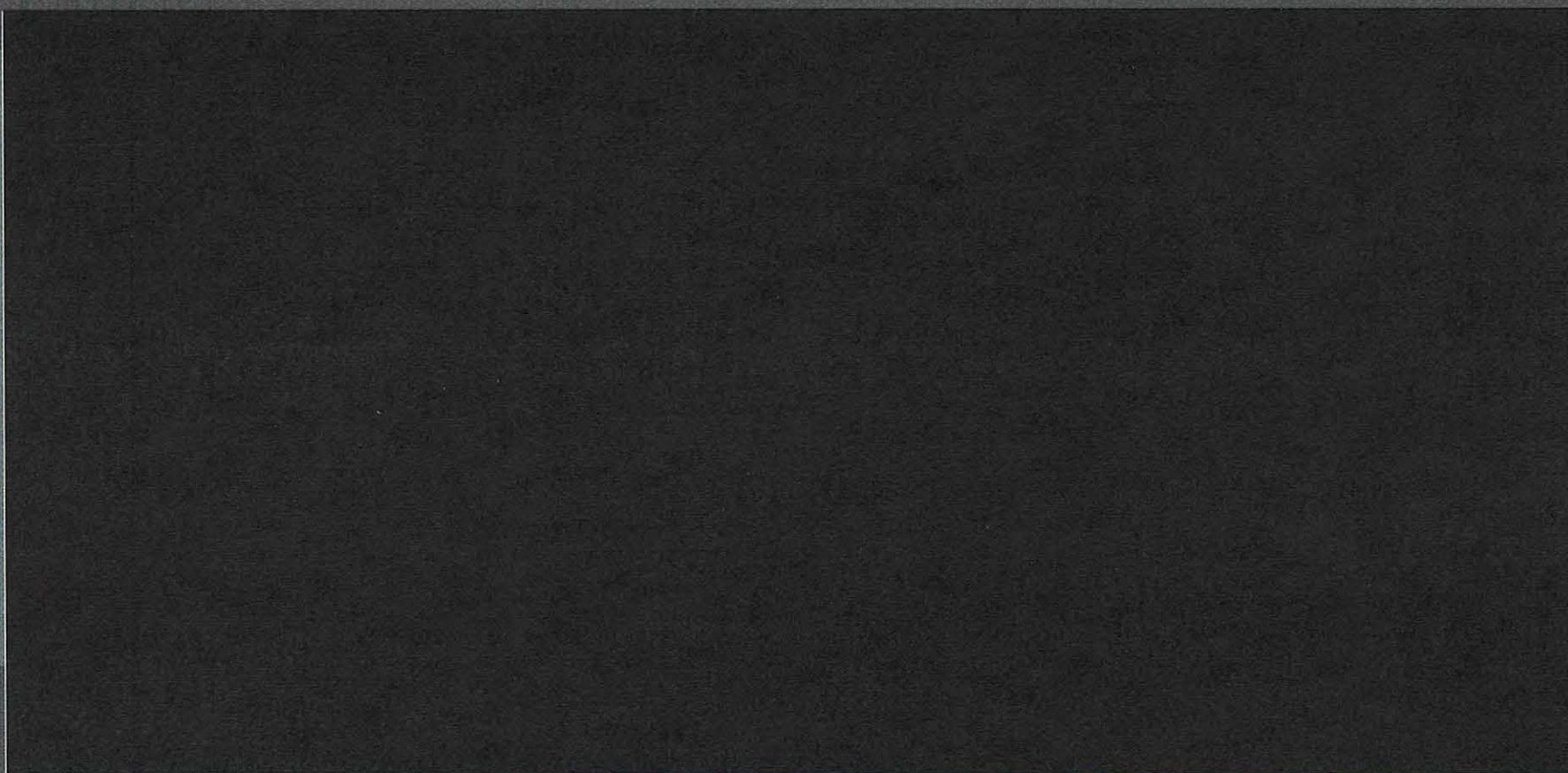

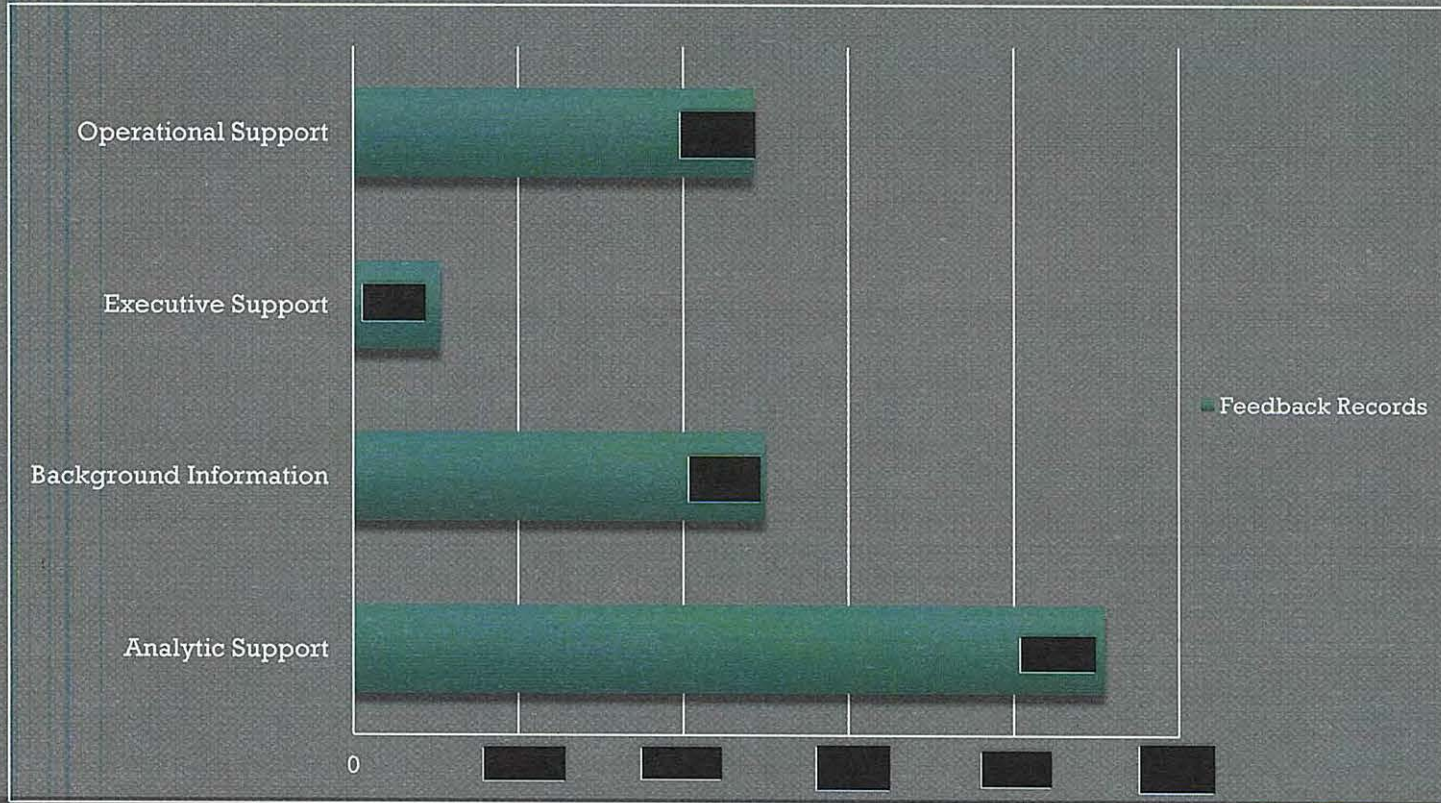

Customer Usage of FAA 702 SIGINT Reports October 2016

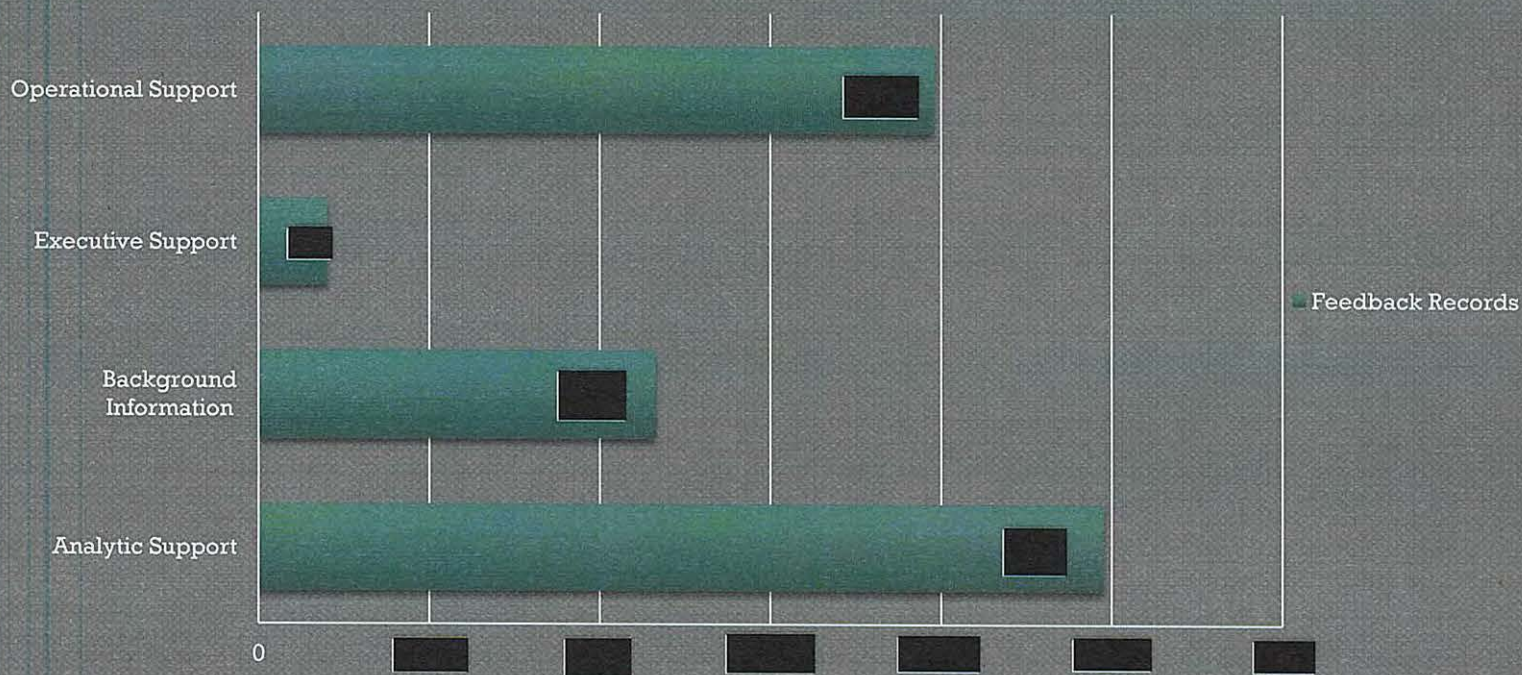
