3. Article 4 - Article 4 of the original Articles of Incorporation is hereby amended as follows:
4. The corporation is organized exclusively for charitable, religious, educational, or scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501 (c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.
