



ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF TAX – EXEMPT  
Transaction Record Analysis Center, Inc.  
(Arizona Non-Profit Corporation)

1. Name: The Name of the Corporation is Transaction Record Analysis Center, Inc.
2. Original date of filing was July 17, 2015
3. Article 4 – Article 4 of the original Articles of Incorporation is hereby amended as follows:
  4. The corporation is organized exclusively for charitable, religious, educational, or scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its member, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 2. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements,) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of October 9, 1969 (or the corresponding provision of any future United States Internal Revenue Law) or: (b) by a corporation, contribution to which are deductible under Section 501(c)(3) of the Internal Revenue Code of October 9, 1969 (or the corresponding provisions of any future United States Internal Revenue Laws).
