3 good cause appearing, the Court FINDS and ORDERS as follows:


4 1. Subject solely to the terms of Paragraph 2 below, the Settlement

11 3. No further claims or matters remain pending between the parties and a
12 final Order concluding this case may be entered;

13 4. Therefore, this final ORDER OF DISMISSAL WITH PREJUDICE is
14 hereby ENTERED and CONCLUDES this case.
