On 2nd February 2022, the Minister for Home Affairs announced an expansion of the Australian Governments countering violent extremism programs. This recent announcement included the establishment of the international Centre of Excellence for CVE Research, Risk Assessment and Training.

On 9th February 2022, the Director General of ASIO in his annual threat assessment raised the issue of an increased instance of a younger cohort (mentioned young children aged 13) observed becoming radicalised since covid.

I've also included a report from one of our Australian colleagues working with Canadian researchers looking at foreign fighters, and another, a 2021 report from one of our CVE collaborators.

Good morning to you both – it was wonderful to chat with the group yesterday. I know this is something you deal with on a regular basis, but I was personally comforted by the collegiality and willingness to collaborate to solve big problems. It felt pretty special to be a part of that.

I'll connect with had during our sync and did the best I could to scribble notes. I didn't know everyone (and their home offices/titles) so did my best to guess quickly with accents and time-references (i.e., how are you tonight, this morning, etc.).

Thinking through the list and my notes I sent to Paul last night, here are some initial comments that I'll think through further (and will get updated by the team on).

1. • 1. Systematic reviews underway by CPN PREV on fit of use and case mgmt – will share with you (though this is not specific to PVE)

Yes, my take-away on fit use/use case was that this is critical (and will be moving forward). Paul's most recent deliverable touched on this a bit, which is good. He's also working on this a bit further, also good. But having documents from CPN PREV when available will be useful and helpful!

2. • 2. Systematic review on juvenile justice – aware of this? If not, we can get our hands on it

Yes, I mentioned this to Paul last night. That literature was included in the larger literature review (so that's good – not missing in that sense), but given Rik's interest will be good to make explicit in final documents. I'll also connect with Erin Kearns (also criminologist, know's Rik's training and background so can help here)

3. • 3. Australia DST mentioned some tools (Trap 18, dtek?, others) – assume you were tracking and aware of these? If not, is there interest to engage directly with DST to dive a bit deeper into what they have?

Yes, the specific tools have been considered and are included in the documentation. In the use case documents, these are also touched on. To help us scope things a bit, this will be discussed once we get to our interviews with USSS personnel, who can help guide things a bit in terms of what they face, specifically.

I will check with the team on this. It's an interesting opportunity. This is certainly a good connection for Matthew on their allies abroad task (that I hope I helped sell/pitch/request?!).

4. • 4. Australia new International COE – are you tracking this? Happy to broker an intro if you/NCITE would like

I am not, personally tracking this (Gina may know, but I tend to be more familiar with the centers in the US). It would be good to connect given the overlap in work. I will always follow your lead on when we can make your group look good by stepping in and connecting (or at least try). I never want to break chain of command so to speak, so as long as you give the blessing, the more the merrier.

5. • 5. Paul Gill – has done a lot of work with UK/AUS/CAN. I assume his prior research is being leveraged to inform Pillar 1? If so, please make sure we give appropriate endorsement. Indeed, this is the case.

With regard to additional comments in my notes:

Brett Kubrick mentioned some quick in Quebec and Paul is tracking that (he's on a board and is familiar). Brett wanted to make sure we were tracking and seem to be, so that's good.

There was some discussion about potential data sources on the tools, but I know that's complicated. It's just a bullet I had in my notes. We can chat offline about that should the need arise.

My other notes were in line with the comments you made, so that was roughly it. I appreciate the follow up and look forward to connecting with Lew next week!
