	[This activity will use a multidisciplinary approach to (1) conduct an outcome evaluation and testing on the general quality and role of threat assessments and threat management programs to

determine whether or not these efforts were successful in achieving its intended objectives, and

(2) conduct an impact evaluation to measure intended and unintended changes that can be attributed to the implementation and outcomes of various threat assessments and models.

The research team will conduct, face-to-face and virtual interviews with stakeholders. The interview format will be a maximum of 1hour per interview, to be conducted over a two-week period if conducted virtually, or over a 2-3 day period if in-person. The research subjects must be 19 years of age or older and utilize threat assessment tools as part of their job responsibilities. This may include members of the Secret Service, USG personnel, and threat assessment personnel at the local and federal level. Interviews will take place at the research teams' facility (UNO) or at the interviewees preferred location (if in person) otherwise they will take place virtually. All Participants will use an anonymous identifier for the study. This study intends to gain a core understanding around perceived utility of threat assessment tools and models (i.e., are current tools any good in practice?) In addition, this study intends to gain a core understanding of practical application of threat assessment tools and models (i.e., how are current tools actually used, if used at all?)
