



- **Dr. James Densley**: Professor and Department Chair of Criminal Justice at Metropolitan State University. He is also Co-Founder and Co-President of <u>The Violence Project</u>, best known for its mass shooter database and the new “<u>Off-Ramp</u>” initiative to reimagine behavioral threat assessment in schools and workplaces. He is the author of six books, 45 peer-reviewed articles, and 70 book chapters and essays. Dr. Densley is a former middle school special education teacher and earned his doctorate in sociology from the University of Oxford.
- **Dr. Stephanic Ellis**: Executive Director of Behavioral Health, Crisis Intervention, and Student Safety where she oversees social emotional and behavioral health implementation and school safety in the Rockingham County School District. She also serves as the Safety Director in which she leads crisis planning, COVID-19 and crisis response, preparation and threat assessment throughout the district. Dr. Ellis has experience and training in coordinating classroom management best practices. She is a PREPare curriculum trainer through the National Association of School Psychologists. Dr. Ellis completed her doctorate at High Point University in the Educational Leadership Program and her dissertation focused on Best Practices in Threat Assessment.
