The draft definition went through several phases of vetting and approvals, mainly:

- Definition was drafted by CP3 in cooperation with S&T, PLCY, and OGC in Spring of 2020
- Draft definition was circulated amongst the TVTP Working Group in July of 2020 for review and feedback
  - TVTP Working Group representation includes: CRCL, CWMD, CISA, FEMA, FLETC, I&A, MGMT, OGC, OLA, OPE, OPA, OUSM, Ops, PRIV, S&T, PLVY, TSA, USCIS, CBP, ICE, USCG, USSS
  - Comments were received from: CRCL, CISA, OELD, PRIV, USCG, OPS, OGC, I&A
- Component comments were compiled in a consolidated draft on August 14<sup>th</sup> for CP3 review and adjudication throughout August 2020.
- Status update on the definition review was provided to the TVTP Executive Steering Committee on August 26<sup>th</sup>
- In September, 2020, CP3 revisited the revised definition with OGC and I&A to clear up remaining questions around authorities.
- Final version of the definition was cleared by OGC in early October and CP3 initiated routing to through S&T to the Department's Lexicographers in mid-October.
