

In FY-2013 we spent \$55,000 through a dedicated CVE officer on CVE-related programs and exchange visits. In FY-2014 we expect to spend close to \$80,000. For FY-2015 we request funding from the Counterterrorism Partnership Fund in the	
amount of \$306,000: \$116,000 in salary costs for a CVE LES (replacing our CVE officer, whose position was abolished) \$80,000 in CVE programming funds and \$110,000 in Public Diplomacy-related CVE outreach/programming. These funds will enable us to build on the momentum and positive results of our intensive CVE engagement and reach broader audiences, and to undertake new initiatives focused on anti-gang efforts and countering extremist messaging.	
Denmark has demonstrated a continued willingness to partner closely with the United States to strengthen European and global security and stability, including on sanctions, international law enforcement, counterterrorism, combating violent extremism, and cyber outreach. Post's Public Affairs Section currently spends 35% of its time and almost half its budget on CVE and ethnic minority outreach programs and looks to increase its successful programming with further resources. In FY-13 PAS spent \$99,500 on such programming and in FY-14 it will have spent \$110,400. Particularly impactful programs on which our CVE officer and PAS have coordinated have included exchange programs, funding training programs for at-risk Danish Muslim youth with Danish businesses and American companies to help them acquire skills and experience to integrate into the workforce, facilitating youth diversity scholarships that allow Danes with ethnic minority backgrounds to attend a year of high school in the U.S., and creating sports diplomacy programs with Danish municipal and community leaders that have literally taken young Danes from these communities off the streets and out of gangs and have them learning values and gaining a sense of positive belonging through teamwork and athletic competition. In addition to continuing such successful programs, Post would use additional funding to establish programming space in one of the larger "new Danish" communities near Copenhagen by partnership with a school, giving us a physical platform to share with members of this community as an outreach center.
