1. Modifications to Statement of Work

The following actions are incorporated into the basic agreement:

Provides funding to support work on projects related to development and evaluation efforts, and the underlying work, leading to the adoption into practice of new tools and technologies for use by state and local criminal justice agencies in the following areas: (1) State centralized, automated, adult and juvenile criminal history record information systems; (2) integrated criminal justice information systems (cjis) to manage and communicate criminal justice information among law enforcement agencies, courts, prosecutors, and corrections agencies, including development of quality assurance tools for sex offender data; (3) court-based cjis systems promoting compatibility and integration with law enforcement and other cjis systems. These efforts are undertaken in furtherance of the recommendations of the Global Justice Information Sharing Initiative (GLOBAL). Activities include execution and/or oversight as further directed of research, development, test and evaluation (RDT&E) projects and funding key personnel in the following areas:

- a) Continue existing RDT&E efforts to assist in the early adoption of technologies through development and implementation of prototypes technologies.
- b) Help to identify requirements through coordinating and hosting meetings for the NIJ Information Led Policing technical working group (TWG) and Courts Technology focus group. Provide key administrative resources to support program objectives, including the administration of TWG and focus group sessions and other program elements. The ILP TWG will have two meetings during this period of performance and the Courts Technology focus group will have one meeting. Cost includes providing: travel, room, and per diem for TWG members.
- c) Test and Evaluate identity management solutions with criminal justice agencies. In collaboration with NII and other resources provide systematic evaluation programs, helping to define and capture user requirements and create partnerships that deliver and leave behind new capabilities in the criminal justice market.
- d) Test and evaluate analytical tools with law enforcement. In collaboration with NIJ and other agencies provide systematic evaluation programs, helping define and capture user requirements and create partnerships that deliver and leave behind capabilities in the criminal justice market. Operators and analysts need visual summarization to increase understanding of threat reporting when presenting information. This effort needs to look at common and non traditional data analysis.
- e) Provide technical assistance in the development of information exchange package documents (IEPDs) for the criminal justice community. Effective education programs can assist practitioners learn about emerging technologies capabilities. Working with criminal justice stakeholders and criminal justice subject matter experts and developing and delivering requested high priority criminal justice IEPD's is even a greater reward. This task will work with the criminal justices community and deliver to the IEPD Clearinghouse vetted, validated, highly recommended IEPD's.

- f) Provide technical business and engineer support on the cost benefits and return on investment of data and voice interoperability planning, design, implementation and operation. Plan, design, implement, and evaluate a test network for law enforcement using next generation technologies. Deliverables of this effort include planning documents, test plans, and cost benefit analysis.
- g) Provide general technology dissemination. Work with NIJ and others to disseminate the research, development, and testing results in a timely manor to the criminal justice community. Provide collaboration mechanisms that support direct automated collaboration amount criminal justice (to include counter-terrorism counterparts) over diverse networks at various security policies.
- h) Continue the research and development of quality assurance tools for the criminal justice community. There has been much discussion regarding Information Quality (IQ) in the Criminal Justice system, both from within Law Enforcement (LE) and from Privacy and Civil Liberties groups who are looking to improve the quality of LE data. This effort will continue the research and development to deliver a proof-of-concept toolkit that will enable law enforcement to determine the validity of sex offender data.
- i) Provide funding for key personnel in support of NIJ activities.
 - 1) ILP program manger detailee.
 - 2) A subject matter expert (SME) in information sharing technology.
 - 3) An SME to identify DoD information technology leveraging opportunities.
- j) In collaboration with the Automated Regional Justice Information Sharing System (ARJIS) field test and evaluate a geographical information sharing system (GIS)-based domestic violence communications system (DVCS) portal.
- k) Provide technical assistance in the area of fusion center collaboration. This effort will provide technical guidance and lessons learned from the formation of existing command and control fusion centers to the current state and local fusion center membership.

This agreement sets forth the terms of an Inter-Agency Agreement between the National Institute of Justice, Office of Justice Programs, Department of Justice (NIJ) and the Space and Naval Warfare (SPAWAR) Systems Center, Charleston on the development of Electronic Crime-defeating related technologies.

I <u>Authority</u>

This agreement is entered into pursuant to: Title II of the Homeland Security Act of 2002 (6 U.S.C. §§161-65) ("HSA); Title I of the Omnibus Crime Control and Safe Streets Act of 1968 (42 U.S.C. §§ 3711 et seq.) ("OCCSSA"); the Economy Act ((31 U.S.C. § 1535); and the Memorandum of Understanding (MOU) between the Department of Defense (DoD) and the Department of Justice (DOJ) on Operations Other Than War (OOTW) and Law Enforcement (LE), executed June 12, 2000, which provides for the collaboration of the departments and their components in development and exploitation of technology and systems that will facilitate accomplishment of OOTW and LE missions.

II Background

NIJ is the research, development, and evaluation arm of the Department of Justice (DOJ) and is dedicated to researching crime control and justice issues. NIJ's principal authorities derive from OCCSSA §§ 201-203 (42 U.S.C. §§ 3721-23) and HSA §§ 231-35 (6 U.S.C. §§ 161-65). Through its Office of Science & Technology (OS&T), NIJ serves as the national focal point for the research, development, testing, and evaluation of technology for law enforcement, including corrections and forensic technologies. NIJ identifies the criminal justice community's requirements for new technologies and develops technologies to meet those requirements. NIJ develops standards and testing programs to evaluate technologies that may be used by law enforcement agencies. NIJ works with other entities within DOJ and other Federal agencies to establish a coordinated Federal approach on issues related to law enforcement technology.

SPAWAR's Intelligence and Information Warfare Systems Engineering Department is responsible for providing hardware and software engineering and technical services in support of

the U.S. Navy, as well as other Department of Defense and government activities worldwide. This department provides engineering studies in the fields of Information Assurance (i.e., Attack, Exploit, and Protect), and Force and Infrastructure Protection Security. Engineering services include analysis, prototype design and testing, site surveys and plans, installations, upgrades, modifications, restoration and removal of systems and equipment, systems life cycle management and logistic support, video teleconferencing, training, LAN/WAN design and administration and cryptologic assurance measures.

NIJ's Electronic Crime Program is designed to address any type of crime involving digital technology, including cyber-crime and cyber-terrorism. The goal of the program is to enable the criminal justice community to better address electronic crime by developing technologies to meet the needs of State and local law enforcement, provide timely information regarding emerging technologies, building and maintaining partnerships among Law Enforcement, Business and Academia, and building capacity for and conduits among Federal. State, and local criminal justice agencies.

NIJ's Information Led Policing Program (ILP) focuses on projects related to information sharing. The goals of the Program are to enable law enforcement agencies to benefit from research and development of emerging open source technologies, records and case management systems, identity management, and information quality assurance. Through collaborative leadership, ILP, strives to serve local, state, tribal, federal and international justice organizations to develop plans and systems that could establish standards, technical assistance and training for the gathering, analyzing and sharing of law enforcement information across all levels of government.

NII's CommTech program focuses on the needs of law enforcement, with a view to all of public safety. NII's CommTech Program focuses on projects related to communications technology and interoperability. Thus, NII will address the needs of law enforcement officers to communicate voice and data primarily. CommTech will fund research to provide new technologies to improve public safety communications. This effort will encompass all elements of NII's RDT&E process, including standards development, testing, demonstrations, evaluation, and technology assistance. In collaboration with DOJ's Global program, NII's CommTech program will provide communications technology to improve information-led policing to prevent crime, improve law enforcement intelligence, inform police deployments, and improve incident response. It is NII's belief that better communications will lead to safer, more effective police operations.

NIJ's efforts in support of the Global Justice Information Sharing Initiative (Global) focus on the needs of criminal justice for information sharing. The goals of the efforts are to continue to support the Global efforts in developing new capabilities in GJXDM and technologies to enhance sharing, privacy, and authentication. NIJ will continue to support and fund efforts in these areas through RDT&E efforts including standards, demonstration, evaluation and technology assistance programs. Furthermore, we will support these efforts through not only in funding but also through key personnel.

The Space and Naval Warfare (SPAWAR) Systems Center Charleston, South Carolina, in partnership with the Naval Consolidated Brig (NCB) in Charleston, South Carolina, and the National Institute of Justice (NIJ) has developed an environment for operation evaluation of leading edge biometric technologies for correctional and law enforcement communities. An example is the ongoing project for the Biometric Inmate Tracking System (BITS) currently employed at the Naval Consolidated Brig (NCB) Charleston, SC and soon to be evaluated in two other State correctional facilities. The continued use of SPAWAR's expertise in biometrics and their operational applications and assessment provides an important contact to the user community for biometrics technology.

The Intelligence and Information Warfare Systems Engineering Department of SPAWAR-Charleston has had a long relationship working with NIJ providing scientific, engineering and contracting support for NIJ's Electronic Crime program. This agreement provides for SPAWAR-Charleston's continued scientific, engineering and contracting support for these programs.

III Statement of Work (SOW)

A. Tasks

SPAWAR-Charleston will provide scientific, engineering and contracting support to accomplish the following tasks:

- Support program goals of NIJ's Electronic Crime Partnership Initiative through the execution of planning agendas, logistics, conducting meetings, exhibiting at conferences where appropriate, and projects including (see the attached NIJ-approved proposal from *Professional Event Planning, LLC*):
 - · NIJ Digital Evidence Guides update,
 - Bag & Tag Electronic Crime and Digital Evidence handling at the crime scene course preparation.
- 2. Support program goals of NII's efforts in support of the GLOBAL program through the execution and/or oversight as further directed of RDT&E projects and funding of key personnel, including (see attached Statement of Work):
 - Pilot program development in support of the Department of Justice's Law Enforcement Information Sharing Plan (LEISP),
 - R&D effort to extract key information from free text and translate the
 extracted information into structured data in a more affordable and
 agency-friendly manner,
 - Provide technology roadmap/guidelines guidance to assist in implementing Global-recommended privacy policies and guidelines,
 - Establish a test-bed laboratory for evaluating many of the technologies developed in the context of Global and information sharing,

- Provide funding for key personnel in support of Global activities, including Paul Embley, Harlin McEwen, and NII visiting scientists.
- 3. Support program goals of NIJ's Biometrics Inmate Tracking System through the continuation of Phase III of the program and implementation of Phase IV to include (please see attached NIJ-approved proposal from SPAWAR Systems Center-Charleston, Law Enforcement and Technology Branch):
 - Installing the new system into the existing NCB's BITS production infrastructure.
 - Develop a BITS installation requirements document.
 - Determination of correctional facilities that meet the parameters of the Requirements document.
 - Perform site surveys at no more than five correctional facilities.
 - Develop and Implementation Plan for BITS.
 - Install and evaluate the BITS.

The total dollar amount provided under this agreement shall be \$2,210,000. Additional funding may be provided through mutual agreement of the parties reflected in modifications to this agreement. Future efforts will be funded in a manner as mutually agreed to by NIJ and SPAWAR-Charleston.

NIJ will distribute funds to SPAWAR-Charleston via the Intra-governmental Payment and Collection System (IPAC).

VII Progress Reports

SPAWAR-Charleston will provide NIJ semi-annual progress reports, on the efforts undertaken on its behalf. These reports shall be in narrative form and shall at a minimum address the following areas:

- 1. Progress made to date on the specific work to be accomplished.
- 2. A summary of work in progress.
- 3. Problems and difficulties encountered.
- 4. Previous problems and difficulties solved.
- 5. Next task(s) to be undertaken.
- 6. Financial status and spending plan for remaining periods.

VIII Modification and Termination

- Amendments or modifications to this agreement must be approved by the each of A. the parties in writing in accordance with applicable policies, procedures, and legal requirements.
- B. Either party may terminate this agreement upon thirty (30) days advance written notice to the other party.
- NIJ and the Office of Justice Programs (OJP) also may terminate this agreement should it have reason to believe that SPAWAR-Charleston is mishandling funds or is unable to carry out the terms of this agreement. OJP will give SPAWAR-Charleston an opportunity to respond to a proposed termination for cause prior to

taking final action. In the event the agreement is terminated for cause, OJP will notify SPAWAR-Charleston, specify the reason for termination, and accord SPAWAR-Charleston a reasonable time to terminate operations under this agreement.

- D. Disposition of any efforts in progress at the time of notification of termination shall be determined by agreement of the parties.
- E. Upon termination of this agreement, SPAWAR-Charleston will repay to NIJ on a timely basis any funds provided under this agreement that have not been expended by SPAWAR-Charleston in accordance with the terms of this agreement.

IX Public Information Disclosure/Coordination

Public disclosures of information regarding projects and activities conducted under this agreement are subject to the Freedom of Information Act (5 U.S.C. § 552). The Parties shall consult with each other prior to any public disclosure of information.

X Limitations

All activities and projects initiated as a result of this agreement are subject to the availability of appropriated funds, and no provision herein shall be interpreted to require obligation or payment of funds in violation of the Anti-Deficiency Act, 31 U.S.C. § 1341.

XI Effective Date

The provisions of this agreement become effective as of the date of the last signature hereunder, and shall remain in effect for five (5) years, unless terminated earlier in accordance with the provisions of this agreement.
