#### **NARRATIVE**

#### WEST ALLIS P.D. SWAT - CITIZEN RESCUE - 25 AUG 2020

Captain Saftig reports...

On Tuesday 25 August 2020, I was the tactical commander for the West Allis Police Department SWAT team. Seven (7) West Allis Police Department SWAT operators were deployed to Kenosha to assist with civil unrest. We were mobile throughout the night in our MRAP Police Rescue Vehicle, assisting with crowd control efforts and holding a perimeter in the area of Sheridan Rd. from approximately 54 St. to 60 St. Throughout the night, we observed several individuals armed, mostly with long guns in the area of 60th St. and Sheridan Rd. Our vehicle, as well as other armored police vehicles and crowd control officers on the ground had been subjected to rocks, bricks, bottles, fireworks and unknown fluids being thrown at us. Our team deployed various less-lethal munitions at target specific individuals who were actively engaged in throwing items at officers and vehicles throughout the night.

My body worn camera (BWC) was activated and captured the following activity. The following is based on my memory and review of my BWC. For continuity and exact quotations, please refer to the recording in its entirety.

At approximately 2345hrs., we were positioned on the north side of the intersection of 60th St and Sheridan Rd. Our Police Rescue Vehicle was facing south. Sgt. Corwin was positioned in the hatch and was monitoring crowds on the south side of the intersection. There were numerous people in the following areas:

5900blk. of Sheridan Rd. - both sides of the street 6000blk. of Sheridan Rd. - in the roadway S/E corner of 60th St. and Sheridan Rd. - vast majority of crowd congregated on gas station parking lot

At approximately 23 minutes into my BWC recording footage, Sgt. Corwin indicated something was going on approximately two (2) blocks in front of us (south on Sheridan Rd.). He said individuals were sprinting to the south.



Kenosha Protests August 25th

My assignment was TEMS (tactical emergency medical services) for the Sauk County ERT (Emergency Response Team), I rode in the bearcat armored vehicle with 7 other team members. I remained in the vehicle during the incident except for medical evaluation of one female National Guard member that had been pulled from the field force line back into the park by the courthouse. She was determined to be stable and the two guardsman with her were instructed to assist her to a designated rescue vehicle that was also in the park. We then proceeded down the street to assist with dispersing the large crowd that had gathered near a gas station. We were then ordered back to the park, we were told by a officer that armor was needed to stage on the NW corner of the park, we arrived at that location to find a field force group that was taking a break as there were no protesters in that location. Within minutes of taking our own personal break and dismounting the bearcat, we were reassigned back to a location approximately half a block north of the gas station where the large crown gathered. We staged at that location for a period of time and observed multiple persons with "military" style rifles on the west side of the street near a business that had been boarded up. I then observed these persons start running south past the gas station. After only a few seconds of that observation, gun shots were heard through our bearcat intercom system that has a microphone located in the driver's side of the vehicle.



I waited with the West Allis Team until a Kenosha police officer arrived and took my verbal statement. Once we were released, I phoned my commander Matt Burch and debriefed him. He instructed me to find a way back to my team in the bearcat. The West Allis team drove me back to the courthouse park where I was able to rejoin my team. From that point on we staged near the park until we were released back to staging at the school.




