We are getting close to turning on the eGuardian interface that will allow VFC to forward its SARs to eGuardian from the Shared Space. Because of the proximity of DC and the fact that your staff already has LEO accounts, the folks at FTTTF and IJIS thought VFC was the right choice to beta test this capability with live data from your system. We are looking at running this test on or about August 20th. Prior to that we will provide familiarization / refresher training to VFC supervisor staff who will have the authority to forward VFC Shared Space SARs to the FBI. I'd like to set up a Telecom to discuss this with you and others you may designate. Could we discuss this on the 12th or 13th in the morning?
