I got this email from (b)(6) on some of the issues they saw in the files sent over to eG. Please take a look and then let's have a call to discuss.

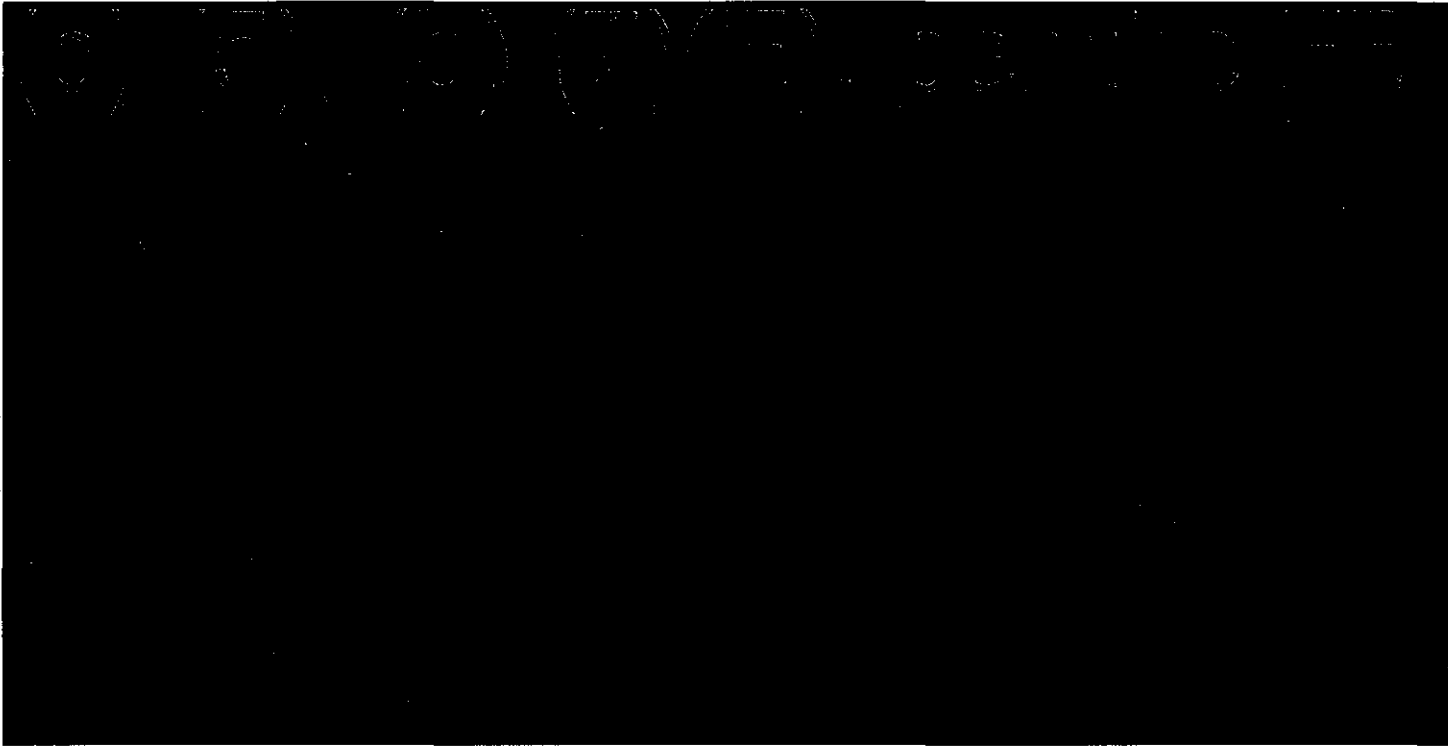
