10. What specific legal authorities, arrangements, and /or agreements authorize the collection of information?

The FBI is assigned the lead role in investigating terrorism and in the collection of terrorism threat information within the United States by 28 C.F.R. § 0.85 and Annex II to National Security Presidential Directive 46. In addition, the Intelligence Reform and Terrorism Prevention Act requires the President to establish an information sharing environment for sharing terrorism information in a manner that is consistent with national security and applicable legal standards pertaining to privacy and civil liberties. Further, the President's National Strategy for Information Sharing supports the eGuardian initiative; it identifies suspicious activity reporting as one of the key information exchanges between the Federal Government and State and local partners.
