Thank you for this, but I thought there were just a couple of items to select from on the status items, e.g. (1) information only, (2) contact needed, etc. Does this make sense.

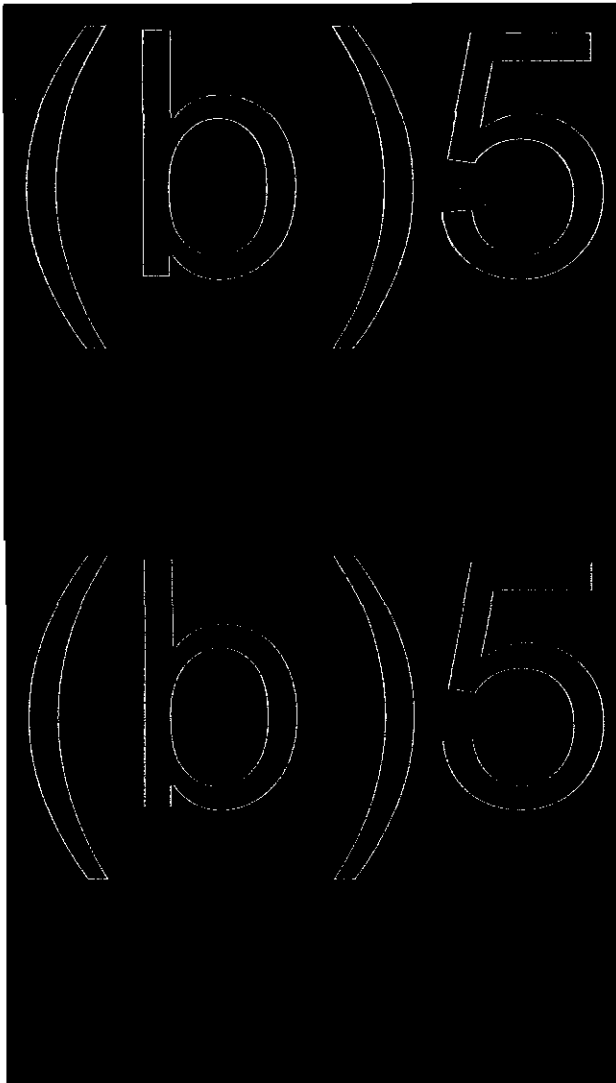
