Instructor, Advanced and Instrument; Airline Transport Pilot  
License. In 1999 they received authorization to train foreign  
born students and have done so since then.

Prospective students can learn about the school via its  
Internet website or by visiting the school itself. When a  
prospective student decides to apply to the school he or she  
could do so by applying via the Internet or by filling out an  
application at the school. In addition, a prospective student  
could provide biographical information to one of the schools  
clerks who would fill out the application for the applicant. The  
application would then be entered into the schools database.

[redacted] voluntarily provided every application made to  
the school since its inception. The school made hard copies of  
each of the applications and provided them to SA [redacted] The  
applications represent any person who applied to the school  
regardless of whether they completed the curriculum or never  
started on a course of instruction for whatever reason. In  
addition, [redacted] provided the names of each of the instructors  
the school has had since it opened.
