This acknowledges receipt in the Department of Homeland Security (DHS) Privacy Office of your Freedom of Information Act (FOIA) request that you addressed to Federal Bureau of Investigation (FBI) seeking records relating to the investigation and surveillance of Muslim communities in Northern California.
