- Our PA team is in communications with OSD-PA now. Given our casualties and the fact that we will have to destroy an aircraft on the ground - I would recommend we adopt a proactive stance to release of information.

I will pass a more detailed update as soon as I receive it from the TF Commander. I do expect that we will not have full details of what happened on the objective until sometime on Sunday after the leadership has had a chance to review all actions with our operators.

We will keep you informed.

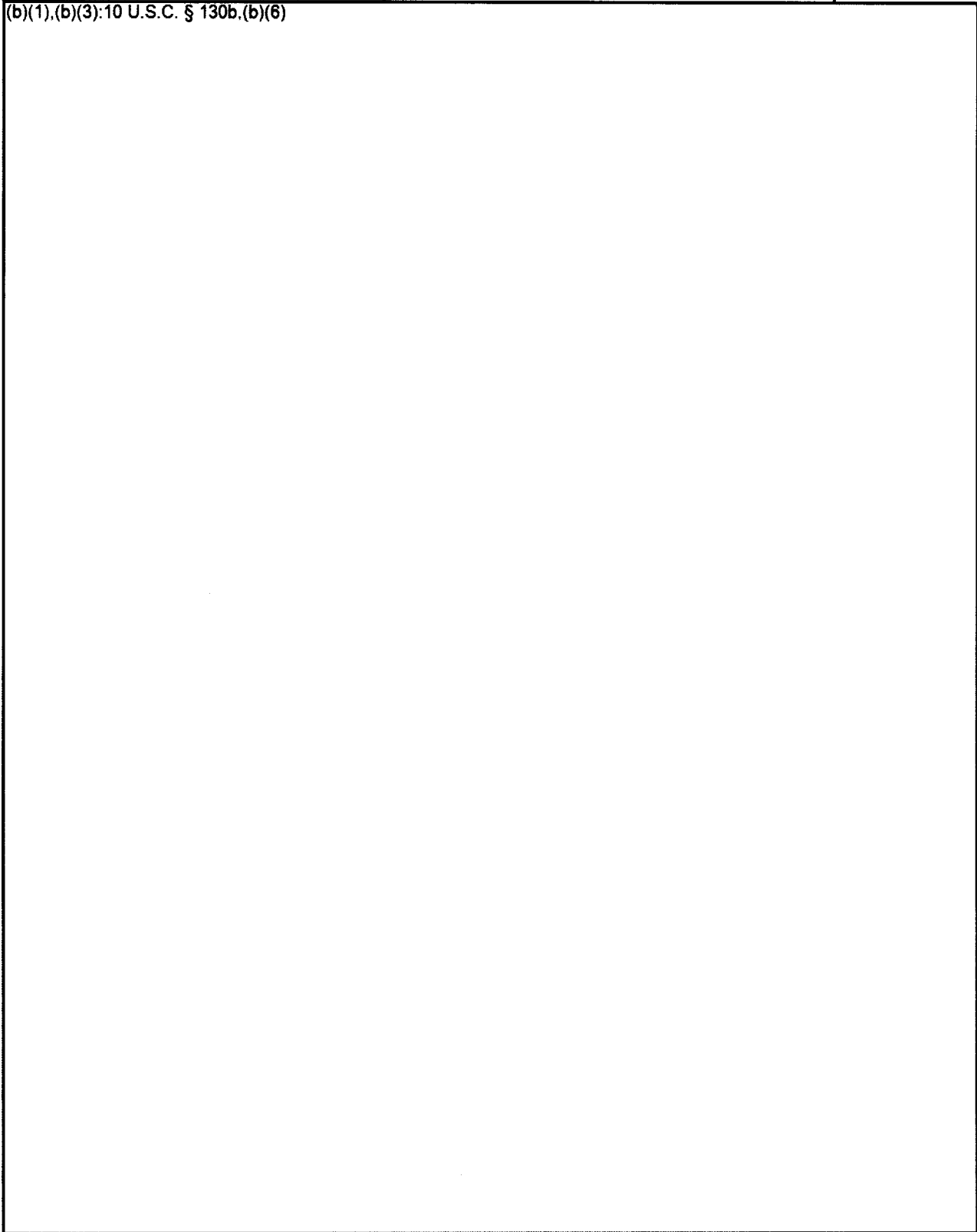

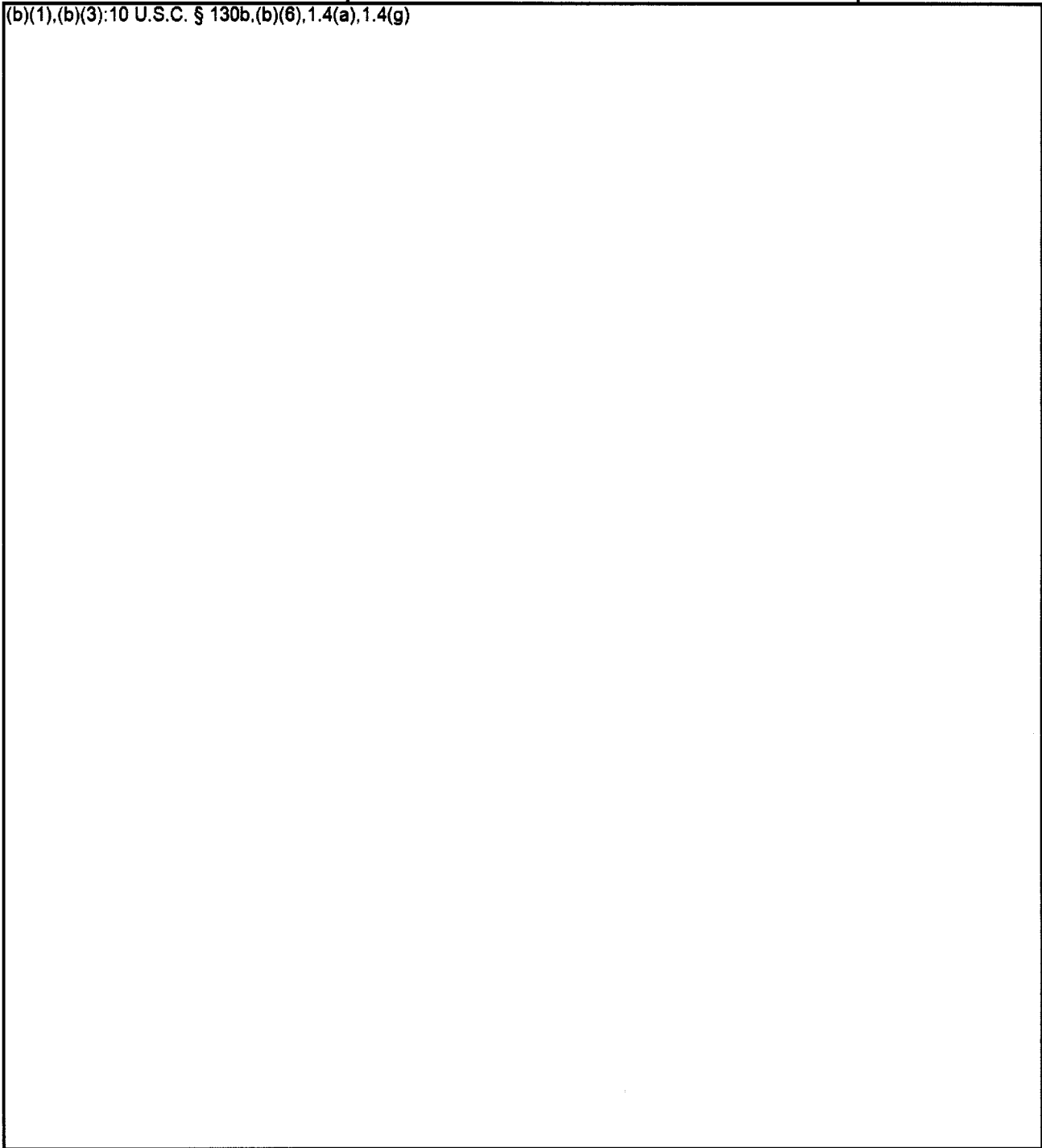

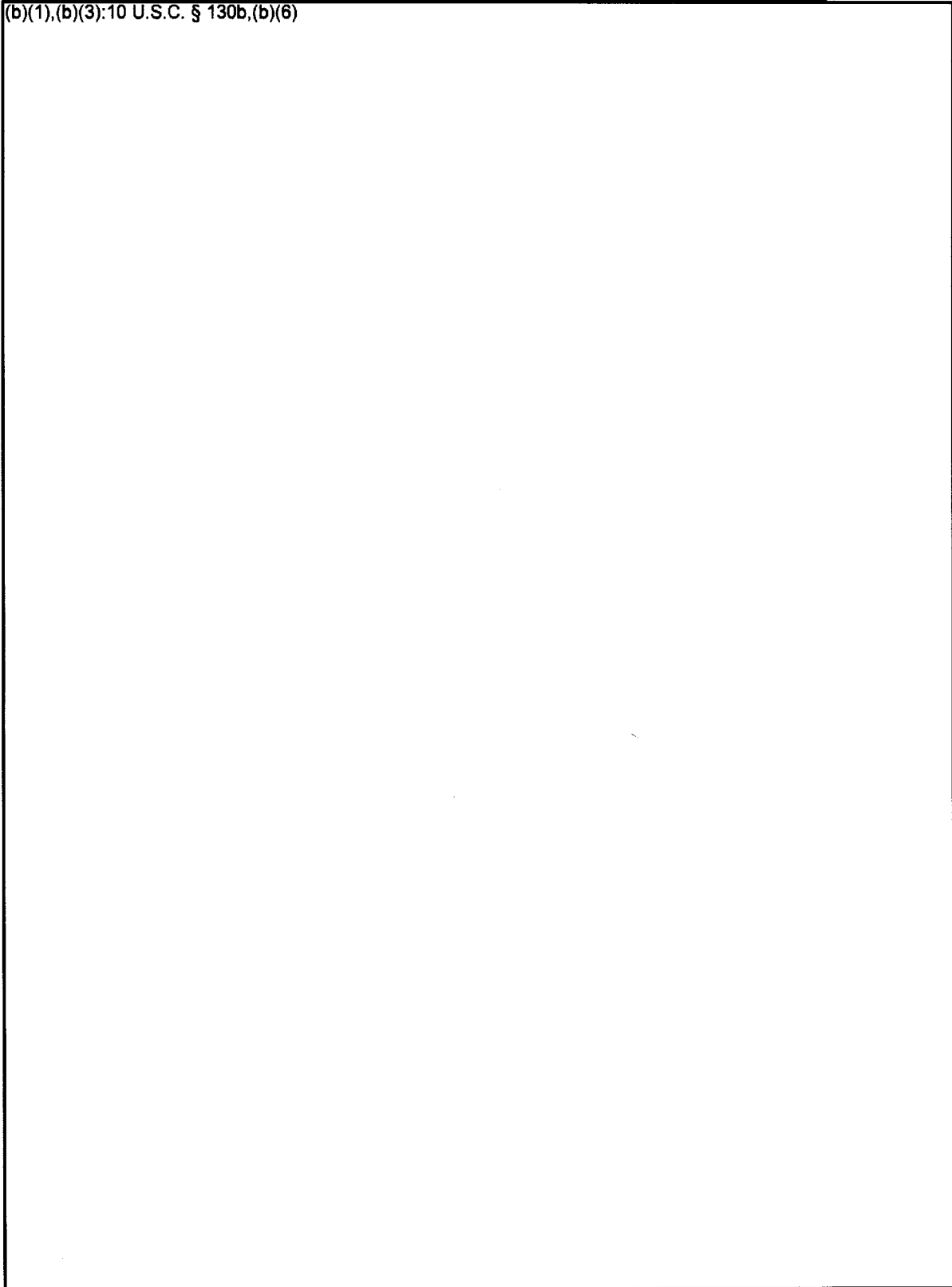
