MELOA President Steve Francis, who's also HSI Detroit's deputy special agent in charge, introduced the group and discussed its mission at the meeting. Hosted by U.S. Citizenship and Immigration Services' (USCIS) Detroit office, the secretary expressed his recognition and thanks for the formation of the group, which is now open to all DHS employees.

In remarks, Francis highlighted MELOA's mission, emphasizing three key initiatives under the organization's theme, "building trust through community engagement:"

- Building trust in Middle-Eastern communities by having DHS agents and officers partner with local law enforcement agencies, non-governmental organizations, schools and community-based groups.

- Creating a platform for DHS personnel of Middle-Eastern descent to engage in mentoring and professional development.
- Combatting violent extremism through sustained charitable and humanitarian activities in the community.

The secretary closed his visit by commenting that he appreciates all of the grassroots efforts that MELOA is engaged in and emphasized how the organization's mission aligns with the department's commitment to community engag
