Tricia,

I attended the "Tiger Team" meeting at the National Counterterrorism Center in McLean earlier this week. Also in attendance were representatives from DHS, DOJ, FBI, DOS, DOD, OMB and the NSC. The "Team" is a dedicated interagency Countering Violent Extremism (CVE) review body. It has been directed by the Deputies Committee with evaluating and making recommendations to the WH on enhancing organizational and management structures of CVE efforts, including what priorities should be pursued based upon departments' and agencies' current authorities and capabilities. The Team will also update the *Strategic implementation Plan to Empower local Partners to Prevent Violent Extremism in the United States.* 

Much of the meeting was devoted to laying out the "Task, Purpose, Roles and Responsibilities" of the group and establishing the meeting schedule. Participants were also asked to develop a 1-2 page document detailing what their respective agencies are doing in the CVE realm.

The review will address all domestic CVE program and is to be completed within 90 days. The group will meet every Monday (hopefully by video conference) and every Thursday (for three hours) in Mclean. It is expected to develop an implementation plan for a national strategy in on CVE.

I have received an e-mail indicating that the next meeting with be held this afternoon at DOJ following the CVE sub-IPC meeting.

While there is interest in the participation of agencies that work in areas that might have an ancillary relation to CVE efforts, I believe that the current work of ORR is a bit distant from the mandate of the working group. In the event that HHS deems it necessary to be represented on the team, this end may be better served by an individual or individuals with a broader knowledge of agency wide work that would or could intersect with CVE work. I have shared with Mark Greenberg and Doug Steiger, who I believe share this view.

I realize that it is very short notice to identify other representation for today and will try to send an ORR staff member, if they can be cleared in time.
