Landing in Qaifa Rada'a, US troops reportedly targeted the house of Sheikh Abdul Rauf alDhab, who was killed along with his brother and all his family members in addition to the Sheikh Saif alNims and other gunmen whom were nearby.

Conflicting reports put civilian casualties between 10 and 16, with claims that women and children were

Some commentators are sensationalizing by highlighting that the children were not killed by accident/collateral of explosion due to inaccurate bomb, but rather targeted and gunned down by US forces. (SBU) Yemeni Reaction to U.S. CT Raid: The Houthi/GPC side has issued a public statement criticizing the U.S. counter-terrorism raid that took place in Yemen on January 29, asserting that the raid was "state terrorism committed by the United States under the pretext of fighting terrorism." The ROYG has not reacted officially. Most Yemeni media articles have been largely factual, reporting that U.S. forces attacked an Al-Qaida base located in Al-Bayda governorate in eastern Yemen. The news reports accurately relate that multiple Al-Qaida operatives were killed in the fighting, and that one U.S. soldier was killed and several injured, and that an Osprey aircraft was destroyed during the incident (some Yemeni reports, however, claim that several U.S. aircraft were destroyed). News sources are also carrying graphic photos of what appears to be burned out debris in the desert. Some Yemeni news sources and social media are claiming that many civilians were killed in the incident (USG sources cannot confirm these claims). There has been a barrage of criticism of the U.S. raid on social media, mainly focused on the purported deaths of civilians amid the fighting, including the alleged death of the eight year old daughter of Anwar al-Awlaqi (the U.S.-born extremist killed in Yemen via a drone strike in 2011).

The ROYG has not reacted officially. Most Yemeni media articles have been largely factual, reporting that U.S. forces attacked an Al-Qaida base located in Al-Bayda governorate in eastern Yemen. The news reports accurately relate that multiple Al-Qaida operatives were killed in the fighting, and that one U.S. soldier was killed and several injured, and that an Osprey aircraft was destroyed during the incident (some Yemeni reports, however, claim that several U.S. aircraft were destroyed). News sources are also carrying graphic photos of what appears to be burned out debris in the desert. Some Yemeni news sources and social media are claiming that many civilians were killed in the incident (USG sources cannot confirm these claims). There has been a barrage of criticism of the U.S. raid on social media, mainly focused on the purported deaths of civilians amid the fighting, including the alleged death of the eight year old daughter of Anwar al-Awlaqi (the U.S.-born extremist killed in Yemen via a drone strike in 2011).

(SBU) **Further on Reaction to U.S. Travel Announcement:** The ROYG has issued its first official reaction to the temporary U.S. visa rules that apply to Yemen and six other countries per the Executive Order on "Protecting the Nation from Foreign Terrorist Entry into the United States" issued on January 27. [Note: According to the Executive Order, the U.S. will not issue visas to Yemenis for a period of 90 days, except for those traveling for diplomatic or for some other specified reasons.] ROYG Foreign Minister Abdulmalik al-Mikhlafi sent out two tweets late January 29 in which he expressed his "dissatisfaction" with the U.S. action. Mikhlafi also asserted that the U.S. action would only support extremists and "plant discord." Houthi/GPC "foreign ministry" sources in Sanaa have been quoted anonymously as calling the temporary ban "illegal and illegitimate"--see Yemen Situation Report for

January 29. Yemenis on social media continue to criticize the U.S. action in strong terms, and are circulating news articles about Yemenis (placing the spotlight on old women and young children) who have reportedly been prevented from boarding flights to the U.S. at various international airports, including Cairo, Djibouti, and Doha. [Note: The U.S. Embassy premises in Sanaa and the area around it continue to be quiet.]

(SBU) **Working Group to Support DDR in Yemen:** YAU Pol-Mil led a conference call on January 26 for members of the "Working Group to Support Disarmament, Demobilization, and Reintegration (DDR) in Yemen." The Working Group includes representatives from the UN OSESGY, YAU, European Union, UK, UNDP, and Germany. Call participants discussed a UN plan to provide a "DDR 101 course to the GCC" to explain the best practices and importance of DDR (Demobilization, Disarmament and Reintegration) to the GCC (Gulf Cooperation Council). The GCC would likely provide substantial funding for DDR programs after a peace accord. The UN has been planning this one- or two-day course since June 2016, and predicts that it will likely take place the first week of March 2017. A State Department CSO-funded DDR Specialist has also drafted a proposed DDR strategy. The Working Group plans to discuss the draft strategy at its next meeting, probably at the end of February or early March.

It's impressive how they adjusted and executed numerous contingencies that had been rehearsed but this was definitely not the way they planned it to go down.

On Jan 31, 2017, at 13:08, Richards, Marie J <<u>RichardsMJ@state.gov</u>> wrote:

The senior [U.S.] military official said the 8-year-old girl, Nawar al-Awlaki, also known as Nora, was among the noncombatants killed in the raid, which also resulted in the death of several Yemeni women. U.S. officials said some of the women who were killed, however, were combatants and had opened fire on the SEALs as they approached the al Qaeda camp.

Whether or not it's true that there were multiple civilian casualties, including children, the article captures the public affairs fallout from the allegations.

Intentional or not, Greenberg said, the deaths of three al-Awlaki family members will enhance the al Qaeda narrative. She noted that as part of propaganda efforts, terrorist groups have begun to circulate photographs of children reputedly killed by U.S. forces. Photos of Nawar al-Awlaki alive and dead are already circulating widely in Arab media.

Al Qaeda in the Arabian Peninsula released a statement via online jihadi media referring to the raid as a "massacre," said U.S. troops had fired on women in children "in cold blood," and accused the SEALs of having "no human values."
