Dear Mr. Handeyside:

I refer to our letter dated January 16, 2020, regarding the release of certain Department of State ("Department") material under the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552. The Department has reviewed 53 additional documents responsive to your request. Of these documents, we have determined that 41 documents may be released in part and 12 documents must be withheld in full. The processing of your request is ongoing.

An enclosure explains the FOIA exemptions and other grounds for withholding material. Where we have made excisions, the applicable FOIA exemptions are marked on each document. All non-exempt material that is reasonably segregable from the exempt material has been released and is enclosed. The documents that were withheld in full were withheld pursuant to Exemptions 3, 5, 6, and 7, 5 U.S.C. §§ 552(b)(3) (b)(5), (b)(6), and (b)(7)(E).
