• Promoting Educational Initiatives to Build Resilience Against Extremist Recruiting: Using the GCTF's CVE and Education good practices as a backdrop, participants will explore educational approaches that can build resilience against violent extremism. They will also consider the benefits of engaging youth at a younger age than CVE programs traditionally target, in order to promote the resiliency that allows youth to reject recruitment later on – these benefits can be gleaned from assessing counter-gang recruitment techniques and education.

• Expanding Professional Training for Youth Susceptible to Radicalization: Participants will discuss efforts to provide vocational and other job training and opportunities as well as good practices and lessons learned that could be applied in developing new programs. This will include, for example, the possibility of developing a network of vocational schools in key regions targeting secondary-level students in vulnerable communities. These schools could be designed in partnership with the local and international private sector to provide general education, English language, and job skills, and offer a direct path to employment.

Session 3: Weakening the Legitimacy and Resonance of the Violent Extremism "Brand": Effective Policies and Programs, Challenges, and Charting a Path for Progress

- Using Strategic Communications, Including Social Media, to Counter Violent Extremist Messaging: This session will highlight effective techniques and strategies to counter violent extremist messaging and narratives in media content, including in online spaces, and deliberate how to effectively and rapidly scale up effective models and mobilize credible voices. Participants will consider how and when messages resonate, and how to assess such resonance. Participants will also identify concrete ways governments and civil society actors can collaborate to counter violent extremist messaging and expose the truth about terrorist organizations. Additionally, participants will identify actionable ways to build upon initiatives and concepts raised by ISIL coalition members during the counter ISIL January 22nd Ministerial in London, UK aimed at countering the group's perverse message.

Amplifying Nonviolent Religious Voices and Education: Participants will explore different efforts to promote religious leader engagement and mainstream religious thought, scholarship, and education as a counter to violent extremist messaging and narratives. They will discuss new tools that could be developed in this area, including, for example, good practices for promoting religious teachings and voices that embrace tolerance and can accommodate modernization, thus providing a credible counterweight to attempts to use religion to justify violence. They will also discuss tangible ways to scale up training and support for religious leaders, including in negotiation, mediation, and community outreach, expanding educational materials that promote critical thinking skills and diversity for schools, and appropriate teacher training programs in communities vulnerable to exploitation by violent extremists. Participants will also seek to identify existing platforms that could be leveraged to advance this agenda and explore whether new platforms are needed. In doing so, they will draw upon the initiatives and proposals from a range of governments and organizations o counter and prevent the spread of extremism by enhancing tolerance, diversity, and non-violence in religious practice and education.
