# Intelligence Oversight DOD 5240.1R

- Implements EO 12333
- Overview
  - Information may be collected about a US person if:
    - Information is germane to Command's assigned mission
    - Information sought falls within 1 of 13 enumerated categories of collectible information
    - Information was properly collected



# Intelligence Oversight US Person

- US citizen
- Permanent resident alien
- Unincorporated association substantially composed of US citizens or permanent resident aliens
- Corporation incorporated in the US, except for a corporation directed and controlled by a foreign government



# Intelligence Oversight Collection of Information

 Information is collected when it has been received for official use.

 Data acquired by electronic means is collected only when it has been processed into an intelligible form.

 Information is not collected when it is forwarded for a collection determination.



### Intelligence Oversight Information Sought

- 13 categories of collectible information
  - Information obtained with consent
  - Publicly available information
  - Foreign intelligence information

(b)(3):10 USC 424, (b)(5)

- Agent of foreign power –
- · Org. owned or controlled directly or indirectly by a foreign power
- Persons/org engaged in intern. terrorist or intern. narcotics
- POWs and MIAs
- Targets, hostages, or victims of intern. terrorist org.
- Corp/org believed to have some relationship w/foreign powers, org or person
- Counterintelligence information (spy/terrorist)
- Physical security information



# Intelligence Oversight Information Sought

- 13 categories of collectible information (continued)
  - Potential source of assistance to intelligence activities
  - Protection of sources or methods (limited to current or former employees)
  - Personnel Security information to support background investigation
  - Communications security information
  - International narcotics activities
  - Safety of person or organization
  - Overhead reconnaissance not targeted against specific US person
  - Administrative purposes



#### Intelligence Oversight Retention of Information

Collection Determination

- Properly obtained information can be retained
- Incidentally acquired information may be retained




#### Intelligence Oversight Dissemination of Information

- Information which was properly collected or retained may be disseminated if the recipient has a need to receive such info for the performance of a lawful government function and is:
  - Employee of DOD
  - Law enforcement entity
  - Agency within the intelligence community
  - Agency of the Federal Government
  - Foreign Government pursuant to an agreement





Organization


 Any group whose existence is formalized in some manner or otherwise functions on a continuing basis

 Applies only to organizations within the U.S. or outside the US that constitute a US person



# Undisclosed Participation: Procedure 10


 Any action undertaken within the structure of the organization







#### Contracts (Procedure 11)

 Commercial organizations, private institutions, and individuals

- Disclosure of IC affiliation is required unless
  - Contract is for published material available to the general public;
  - Contract is for routine goods or services; or



# xperimentation on Human Subjects (Procedure 13)

 Prohibited for Intelligence Purposes unless subject consents



# Employee Conduct (Procedure 14)

 Employees must act in accordance with EO 12333 and DoD 5240.1-R

 Employees must be familiar with EO 12333 and DoD 5240.1-R



# Questionable Activity (Procedure 15)

- Definition
  - Any conduct that constitutes, or is related to, an intelligence activity that may violate the law, any EO, or DoD policy
- Responsibility
  - Of every employee
- Report
  - IG, GC, supervisor, IOO
