Goals:

1. Combat crime and drug activities in multi-jurisdictions / four counties
2. Arrest DUI offenders in multi-jurisdictions /four counties
3. Arrest Drug impaired drivers in multi-jurisdictions / four counties
4. Arrest Drug traffickers and users in multi-jurisdictions / four counties
5. Stop criminal activities that happen on local, state and federal highways in multi-jurisdictions.
6. Hire a full time DUI/ Drug deputy to work in multi-jurisdictions / four counties

Description of strategies to be used

South Eastern Idaho is a major corridor for visitors to West Yellowstone, Jackson Hole Wy., Canada, and Mexico. Since most law enforcement agencies in our area are small in man power, the ability for departments to have specialized DUI/Drug drug deputy to combat criminal activities on the roads in Eastern Idaho is something that is needed. With this grant we can hire one officer that will be assigned to full time criminal interdiction on local, state and federal roads in Eastern Idaho. This officer will be deputized to enforce laws and work in Teton County, Madison County, Fremont County, and Clark County, as well as the cities in each county. In the past, we have had multi-agency drug task force and the cooperation between these counties has been very productive.

Numerical listings of key/major deliverables:

1. One full time DUI/Drug enforcement deputy for 2 years
2. Fully equipped police car with computer and license plate reader

Coordination of plans: The new deputy will work with the patrol Lt. of the Madison County Sheriff's Office. Each of the other counties will have a primary point of contact for the deputy assigned. The deputy will also work with the Upper Valley multi-county Major Crime task force with incidents of drugs and major crimes. The assigned deputy will also work with all 4 county dispatchers for coordination of his availability.

Eligibility:

The 2000 U.S census gives Madison County a population of 27,467 and the estimated 2007 population is 36,647. The other 3 counties where the deputy will be working have a total between them of 21,772 with the 2007 population estimates.

Program Narrative:

1. Statement of the problem

Madison County Sheriff's Office is applying for funding under category 1: Combating Rural Crime. Law enforcement departments in Eastern Idaho are small in personnel, but large in square miles covered. We are requesting funding to hire one deputy that will be assigned full time to working the roads in Eastern Idaho to combat crime, including DUI, Drug trafficking and interdiction. Currently, there are not enough officers to have a specialized officer to take care of rural crime on the roads in Eastern Idaho.

Madison County Sheriff's Office has only one deputy on patrol at a time to cover 471 sq miles. Fremont County has two deputies on patrol to cover 1,866 sq miles which includes popular resort areas. Teton County has one officer covering 450 square miles. Clark County has a total of three deputies to cover all shifts patrolling 1,866 sq miles; this means that there are times with no officer on duty. Looking at the State of Idaho Department of Transportation statistics, Madison County has peak car usage rate of 22,780 per day, Clark County- 3,400 per day, Teton County- 7,000 average per year and Fremont County- 10,000 average per day. During the peak tourism months, the yearly average can go up as much as 50% per area.

In 2008 there was 55 DUI arrest in Madison County, 55 DUI arrest in Teton County, 20 DUI arrest in Fremont County. In Clark County there was 4 DUI arrest due manpower. Even though

there was a few DUI arrest, most of these were called into 911 centers by drivers on the road that observed reckless driving.

Due to the low budgets between the 4 counties, it is not possible to hire a fulltime DUI/Drug enforcement road officer. (Letters of support are attached) Also, due to budgets, we are requesting a SUV patrol vehicle equipped with all necessary police equipment. Since this deputy will be working multi counties, we are also requesting a mobile computer and license plate reader to make the officer more efficient. Many agencies nation wide consider video cameras, computer and radars standard issued equipment, but between the 4 counties, there is only one officer with a mobile computer.

In the last month we have compiled a hiring list of potential new hires. They have completed the physical test, written test, interviews and physiological test. These candidates have been ranked and hiring of new officers will be from this list. Hiring of a new officer could be completed within 2 weeks with the officer on the road. If the grant is approved, we will look at experienced candidates within the 4 county sheriff's office and assigning one of them to take the position of the specialized deputy assignment. We will then take the highest ranked candidate on the hire list and assign them to the patrol unit creating a new job, and not creating a supplanting issue.

## 2. Program design and implementation:

Madison County Sheriff's Office will hire one full time officer to work local, state and federal roads to combat crime in 4 counties covering 4,550 square miles. This officer will use a mobile computer to keep track of his statistics which would include but not be limited to: DUI arrests, Drug arrests, traffic violation arrests, number of traffic stops, mileage covered, multi-agency

assist combating crime, number of tips/leads given to other agencies ect.. Our goal would also be to increase the arrests from previous years. These are all measurable goals and outcomes that can show the effectiveness of the officer. Hiring a new officer and increasing our manpower creates a job which is part of the Recovery Act. This grant award will be used as seed money to help our specialized officer fully set up and get on the road. At the end of the 2 years we plan to keep this specialized position by using general county funds from all 4 counties. Funding will start to be assigned once the award is made so retention of this new position will accure.

Category 1 refers to preventing and responding to rural crime. We will be using the ILP approach to the specialized traffic officer by: looking at past crimes and hot spots on the roadways, use covert and overt means with the help of the Upper Valley Drug and Major Crime task Force combating crime, using focused enforcement tactics and other ILP approaches.

By having this specialized officer on the road he will be able to prevent, respond and combat crime in the areas of: narcotic trafficking, drug distribution, gang violence, vehicle thefts, thefts, DUI by drugs or alcohol, and gaining information from informants and violators. Some of these areas will be completed by: traffic stops of violators, use of the license plate reader that is hooked up the National Data base, and cooperation and information sharing between the different counties.

As mentioned above, this money will be used as seed money to start our specialized officer to get him out on the road and start combating crime. After the 2 years the officer will be fully equipped and trained as money from the general fund from the 4 counties will build and be used to retain the officer in his position. This funding will begin accruing once the grant starts.

As mentioned above in the statement of problem section, we will be using computer data to analyze the effectiveness of the officer as well as assisting him with where to patrol. Our current CAD system has the capability to collect data that can be used to improve the effectiveness of the officer as well as showing how effective he is with arrest and competing our goals and objectives.

A time line of implementing this grant is included in Attachment 4 per the grant application.

### 3. Capabilities/Competencies:

The proposed management of this grant will be with the patrol Lt of the Madison County Sheriff's Office. He will oversee the specialized officer with coordination of shifts and working with the other counties. Since this is a multi-Agency assigned officer, the Lt. will have a designated officer assigned from each of the 4 counties as the point of contact for the specialized officer. All 4 sheriffs have talked to the patrol Lt already about this possible grant and are excited about the possibility of implementing this officer soon and have signed letters of support- attached. Since the officer will be Madison County Sheriff's Office employee, the Madison County Clerks office will work with the patrol Lt. in tracking draw downs and grant expenditures. The clerk's office will set up a line item in their budget specifically for this grant of combating rural crime. The patrol Lt and county clerk currently work together on other federal and state grants with draw downs and expenditures with great success.

5. Impact/Outcomes:

Madison County Sheriff's Office is willing to participate in evaluations managed by the National Institute of Justice. This project's effectiveness will be demonstrated by statistics from: narcotic trafficking arrests, drug distribution arrests, gang violence arrests, vehicle thefts recovered, thefts, DUI /Drugs or alcohol arrests, gaining information from informants and violators, and other agency assists.

Performance measures:

1. Narcotic trafficking arrests: Data collected will be arrest numbers. Data will be collected from the CAD computer system when an arrest is made or citation issued. These numbers will be analyzed by the Patrol Lt and other points of contacts from the other sheriff's offices. With these numbers they will be able to look at crime patterns and assign the officer to work these areas more. All this information gathered will also be passed onto other officers in the different agencies as will at the multi county major crime and drug task force.
2. Drug Distribution arrests: Data collected will be arrest numbers. Data will be collected from the CAD computer system when an arrest is made or citation issued. These numbers will be analyzed by the Patrol Lt and other points of contacts from the other sheriff's offices. With these numbers they will be able to look at crime patterns and assign the officer to work these areas more. All this information gathered will also be passed onto other officers in the different agencies as will at the multi county major crime and drug task force

3. Gang Violence arrests: Data collected will be arrest numbers. Data will be collected from the CAD computer system when an arrest is made or citation issued. These numbers will be analyzed by the Patrol Lt and other points of contacts from the other sheriff's offices. With these numbers they will be able to look at crime patterns and assign the officer to work these areas more. All this information gathered will also be passed onto other officers in the different agencies as will at the multi county major crime and drug task force.
  
4. Vehicle Thefts recovered: Data collected will be recovered numbers. Data will be collected from the CAD computer system when a vehicle is recovered. These numbers will be analyzed by the Patrol Lt and other points of contacts from the other sheriff's offices. With these numbers they will be able to look at crime patterns and assign the officer to work these areas more. All this information gathered will also be passed onto other officers in the different agencies as will at the multi county major crime and drug task force
  
5. Thefts: Data collected will be arrest numbers, and recovered stolen property. Data will be collected from the CAD computer system when an arrest is made property is recovered. These numbers will be analyzed by the Patrol Lt and other points of contacts from the other sheriff's offices. With these numbers they will be able to look at crime patterns and assign the officer to work these areas more. All this information gathered will also be passed onto other officers in the different agencies as will at the multi county major crime and drug task force



6. DUI /Drugs or alcohol arrests: Data collected will be arrest numbers. Data will be collected from the CAD computer system when an arrest is made or citation issued. These numbers will be analyzed by the Patrol Lt and other points of contacts from the other sheriff's offices. With these numbers they will be able to look at crime patterns and assign the officer to work these areas more. All this information gathered will also be passed onto other officers in the different agencies as will at the multi county major crime and drug task force.
  
7. Gaining information from informants and violators: Data of current information and tips will be collected by the assigned specialized deputy. He will work with the multi county major crime and drug task force share information. The task force also keeps track of information and will then inform other deputies and citizens. The task force and specialized deputy will analyze the information and work with the other counties sheriff's offices and police department to make the information more valuable.

How many partnerships were formed this quarter that prevented reduction in services or duplication of efforts? The patrol Lt. will work with the assigned DUI/Drug deputy and with assigned designates contact person from each of the sheriff offices and figure out the specific data information and then use the data to figure out the partnerships.

The deputies will also be working with the region drug force that is on a grant and keep statistics on tips and leads gathered by the deputies. The number of submissions reported to the data bases will be kept track by the sheriff's office computer CAD system that has this capability.

Budget Revision Request

A. Personnel:

Original Request: We will hire one new officer increasing our work force by one. Pay rate will be \$17.00 per hour = \$35,360 per year times 2 years = \$70,720 Federal funds requested.

New Request: \$17.00 per hour x 1991.76 hrs. per year = 33859.92 x 2 year = \$67,720 – New amount

D. Equipment:

Original Request: Since we will be hiring a new officer, we will need a police vehicle for him to drive. We have no extra police vehicles and with our current fleet, over 50% are above 120,000 in mileage. We are budgeting \$29,000 to purchase a SUV due to the winter condition in Eastern Idaho. We have budgeted \$17,000 to purchase the required police equipment to outfit the SUV: 700 MHz radio, emergency lights, barrier, radar, video camera, gun locks, siren and other required equipment. Since this officer will be working multi counties, we will purchase a computer for the car that has wireless data. In many areas a computer is a standard piece of equipment, but due to local budgets, there is only 1 patrol vehicle in the 4 counties with mobile data available. With the computer in this car, it will make the officer more effective with his time by doing reports, issuing citations, checking for warrants, checking gang files, terrorist files and sharing information back and forth from dispatch and other agencies directly from his car. \$5,000 has been budget for this computer with wireless data. Also with this computer, it will be hooked up to a mobile license plate reader. This license plate reader will be hooked into the State NCIC system connected to millions of hot lists. The unit is capable of reading up to 3,600 plates per minute, and giving information on stolen plates, terrorist suspects, gang suspects, Amber Alert, and Wants and Warrants. There are no license plate readers in Eastern Idaho and with the approval of the grant we will let other agencies know about the availability of this and make it and the officer available. The cost of this unit is \$21,373.

Total cost of equipment is \$72,373- federal funds requested-Old request

New Request: This grant is for an officer to be working 5 different counties doing criminal interdiction. Due to the daily mileage that is put on the patrol SUV, it is now out of warranty. We currently have a maintenance program of oil changes and other required maintenance needs but since we are a small department of 20 vehicles this is

done at a local vehicle dealership and out of our budget. The SUV's engine computer is having issues and giving warning lights daily saying there is something wrong with the patrol vehicle and the dealership is unable to find the problem. We are requesting \$2,000 to replace the engine/SUV computer that runs all components of the vehicle and engine. We are also requesting \$1000 for new tires due to the daily mileage that is put on and since we had not budgeted for tires in our sheriff's office budget for this grant vehicle.

Budget - Same as above and then add a new engine computer at \$2000 and new tires at \$1000. Then \$3000 from personal to cover this \$3000 shortage now making equipment new request \$75,373.

We will then take the next listed person on our current hiring list that has completed the initial testing and offer him a job. Within a month the new officer will be working.


