Request for Information: Countering Violent Extremism Efforts in Boston, Minneapolis/St. Paul, and Los Angeles

Suspense: COB Monday, 24 March 2014

Background Information / Purpose: In cooperation with the White House, Department of Justice, Federal Bureau of Investigation, National Counter Terrorism Center, and other Federal partners, DHS is attempting to improve their support to Federal, State, local, and tribal partner efforts to counter violent extremism and prevent violent attacks. DHS is engaging with the cities of Boston, Massachusetts; Minneapolis/St Paul, Minnesota; and Los Angeles, California to develop an integrated national model to facilitate the creation and support of pre-existing sustainable grassroots efforts to counter violent extremism and prevent violent attacks. The first step in this process is determining a baseline of current and ongoing countering violent extremism or related activities. (Suggested examples include conducting security assessments on faith-based community houses of worship; active shooter training; information shared via web portals regarding behaviors and indicators to prevent violent attacks.)

Please submit any current related efforts, to include both Headquarters and field-based activities, undertaken in the areas of Boston, Minneapolis/St Paul, and Los Angeles. Please provide your submissions and/or adjudications to the attached document, which is currently populated with material from DHS CRCL; please note that certain PSA activities—such as faith-based engagement—is present.
